- 1. The House met, at three o'clock p.m., pursuant to adjournment.-Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. Petition.—Mr. Menzies (Leader of the Opposition) presented a Petition from certain electors of the Divisions of Herbert and Kennedy, praying that no further steps should be taken by the Government towards the nationalization of the banking system without first seeking the authority of the Australian people. Petition received and read.
- 3. Leave of Absence to Member. -Mr. Chifley (Prime Minister) moved, by leave, That leave of absence for one month be given to the Right Honorable Member for Yarra (Mr. Scullin), on the ground of ill-health. Question—put and passed.

Page 1, after clause 2, insert the following new clause:---

"2A. The Arbitration (Public Service) Act 1911 is repealed.".

Repeal of Arbitration (Public Service) Act 1911.

On the motion of Mr. Chifley (Treasurer), the Amendment was agreed to, after debate. Resolution to be reported.

The House resumed; Mr. Clark reported accordingly. On the motion of Mr. Chifley, the House adopted the Report. 28th October, 1947.

10. BANKING BILL 1947.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-

Debate resumed.

Suspension of Standing Orders.-Mr. McEwen moved, That so much of the Standing Orders be suspended as would prevent Mr. Fadden from concluding his speech without interruption. Question—put and passed, with the concurrence of an absolute majority of the Members of the House.

Debate continued.

Mr. Howse moved. That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

11. ADJOURNMENT.-Mr. Scully (Vice-President of the Executive Council) moved, That the House do now adjourn. Question—put and passed.

And then the House, at nineteen minutes past ten o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
