New Guinea Timber Rights Royal Commission—Report—Ministerial Statement—Motion for Printing Paper.—Mr. Chifley (Prime Minister), by leave, made a Ministerial Statement with reference to the findings of the Royal Commission appointed to inquire into certain transactions in relation to timber rights in Papua-New Guinea, and informed the House that, as the findings show that the charges against the Minister for External Territories were completely without foundation, he had asked Mr. Ward to resume administration of his Ministerial offices. Mr. Chifley then, by command of His Excellency the Governor-General, laid upon the Table the following Paper:
