- 1. The House met, at three o'clock p.m., pursuant to adjournment.-The Deputy Speaker (Mr. Clark) took the Chair, and read Prayers.
- 2. ALTERATION OF HOUR OF NEXT MEETING .-- Mr. Chifley (Prime Minister) moved, That the House, at its rising, adjourn until to-morrow at half-past ten o'clock a.m. Question—put and passed.
- 3. ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION .- Mr. Menzies (Leader of the Opposition) rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The present coal strike; ways and means of maintaining the fullest possible supplies of coal to the public; and the urgent necessity for the taking of adequate measures to defeat the strike ".

Mr. Deputy Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly-Mr. Menzies moved, That the House do now adjourn.

Ordered-That Mr. Menzies be granted an extension of time.

Debate ensued.

Sir Earle Page moved, That Mr. Anthony be granted an extension of time.

Question—put and negatived.

Debate continued.
