Japanese War Crimes Trials-Ministerial Statement-Motion for Printing Paper.-Mr. Menzies (Prime Minister), by leave, made a Ministerial Statement with reference to the trial of alleged Japanese war criminals and informed the House that an Australian military court would be established at Manus and suspects brought to trial as speedily as possible.
