- 5. MINISTERS OF STATE BILL 1951.-Mr. Menzies (Prime Minister) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the Ministers of State Act 1935-1947. Question—put and passed.
- 6. Foreign Affairs-Ministerial Statement-Motion for Printing Paper.- The Order of the Day having been read for the resumption of the debate on the following motion of Mr. Casey (Minister for External Affairs), That the Paper [presented on the 21st June, 1951], viz. :-Foreign Affairs-Ministerial Statement, 21st June, 1951-

be printed-

Debate resumed.

Ordered-That Mr. Haylen be granted an extension of time.

Debate continued.

Mr. Thompson was granted leave to continue his speech when the debate is resumed.

Ordered—That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for the next sitting.

7. CONSTITUTION ALTERATION (POWERS TO DEAL WITH COMMUNISTS AND COMMUNISM) BILL 1951.- The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-

And Mr. Evatt (Leader of the Opposition) having been called upon to speak-

Point of Order.—Mr. Wentworth raised a Point of Order that the Right Honorable Member, having appeared professionally in the Court on the subject matter of the Bill, was, in accordance with the Ruling from the Chair on the 13th March, 1951, not entitled to speak in this debate.

Speaker's Ruling .- Mr. Speaker ruled that, as Mr. Evatt had appeared in Court in a case dealing with the matter, he was debarred from speaking or voting in the House on the subject under discussion. 10th and 11th July, 1951.

Mr. Eric J. Harrison (Vice-President of the Executive Council) moved, That so much of the Standing Orders be suspended as would prevent Mr. Evatt from making his speech. Debate ensued.

Mr. Calwell proposing to move, That the Speaker's Ruling be dissented from-

Speaker's Ruling.—Mr. Speaker ruled that it was now too late to dissent from the Ruling and that any action thereon would need to be on notice.

Question—That so much of the Standing Orders be suspended as would prevent Mr. Evatt from making his speech—put and passed.

Debate resumed on the motion, That the Bill be now read a second time.

Ordered - That Mr. Evatt be granted an extension of time.

Mr. Holt (Minister for Labour and National Service) moved, by leave, That so much of the Standing Orders be suspended as would prevent Mr. Evatt from continuing his speech without limitation of time.

Question--put and passed.

Debate continued.
