Sir Arthur Fadden moved, by leave, That the Bill be now read a second time.

- (b) in respect of goods covered by the Third Schedule to the Sales Tax (Exemptions and Classifications) Act—33<sup>1</sup>/<sub>3</sub> per centum;
- (c) in respect of goods covered by the Fourth Schedule to the Sales Tax (Exemptions and Classifications) Act—50 per centum ; and
- (d) in respect of goods not covered by the Second, Third or Fourth Schedule to the Sales Tax (Exemptions and Classifications) Act, but subject to the exemptions provided by that Act—12½ per centum.

2. That, for the purposes of this resolution, "the Sales Tax (Exemptions and Classifications) Act " mean the Sales Tax (Exemptions and Classifications) Act 1935-1951 as proposed to be amended by the Sales Tax (Exemptions and Classifications) Bill 1952.

Progress to be reported, and leave asked to sit again.

The House resumed ; Mr. Bowden reported accordingly. Resolved—That the House will, at the next sitting, again resolve itself into the said Committee.
