SO-CALLED PEKING "PEACE" CONFERENCE-MINISTERIAL STATEMENT.-Mr. Menzies (Prime Minister), by leave, made a Ministerial Statement regarding the travel of Australian delegates to the so-called "Peace" Conference to be held in Peking China towards the and of the same Conference to be held in Peking, China, towards the end of the present month. Mr. Menzies stated that the Government would not be a party to assisting any Australian to attend the Conference and, accordingly, would deny passport facilities to all prospective delegates. Mr. Evatt (Leader of the Opposition), by leave, also made a Statement in connexion with the matter.
