- 4. MINISTERIAL STATEMENT-LEAVE TO MAKE NOT GRANTED .-- Mr. Casey (Minister for External Affairs) asked leave to make a Ministerial Statement in connexion with the Katyn massacre. Objection being raised, leave not granted.

Debate ensued.
