1. The House met, at half-past two o'clock p.m., pursuant to adjournment.-Mr. Speaker (the Honorable A. G. Cameron) took the Chair, and read Prayers.

Defence Transition (Residual Provisions) Act—National Security (Industrial Property) Regulations-Order-Inventions and designs. Excise Act-Regulations-Statutory Rules 1953, No. 86. Public Service Act-Appointments-Department-Civil Aviation-I. D. Odgers.

3. INCOME TAX AND SOCIAL SERVICES CONTRIBUTION ASSESSMENT BILL (No. 2) 1953.-The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-

Debate resumed.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clauses 1 to 6 agreed to.

Clause 7-

On the motion of Mr. Holt (Minister for Labour and National Service), the following amendment was made :-

Page 3, lines 13 and 14, omit "Queen Elizabeth the Second Coronation Trust Fund for Mothers and Children", insert "Queen Elizabeth the Second Coronation Gift Fund". Clause, as amended, agreed to.

Remainder of Bill, by leave, taken as a whole, and agreed to, after debate. Bill to be reported with an amendment.

The House resumed ; Mr. Adermann reported accordingly.

On the motion of Sir Arthur Fadden (Treasurer), by leave, the House adopted the Report, and, by leave, the Bill was read a third time.

4. INCOME TAX AND SOCIAL SERVICES CONTRIBUTION BILL 1953.-The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to. Bill to be reported without amendment.

The House resumed ; Mr. Adermann reported accordingly. On the motion of Sir Arthur Fadden (Treasurer), the House adopted the Report, and (the Standing Orders having previously been suspended, see page 715), the Bill was read a third time.

Debate ensued.

Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole.

Mr. Evatt (Leader of the Opposition) moved the following amendment :---Clause 6, page 5, at the end

is satisfied that in the case of goods imported for resale the benefit of the refund will be passed on to the purchaser or purchasers of such goods.".

Debate ensued.

Progress to be reported, and leave asked to sit again.

The House resumed ; Mr. Adermann reported accordingly. Resolved-That the House will, at a later hour this day, again resolve itself into the said Committee.

WHEAT MARKETING BILL 1953.—Mr. McEwen (Minister for Commerce and Agriculture), pursuant to leave given on the 9th October, brought up a Bill intituled "A Bill for an Act to amend the 'Wheat Industry Stabilization Act 1948-1953 '", and moved, That it be now read a first time. Question—put and passed.—Bill read a first time.

Mr. McEwen moved, by leave, That the Bill be now read a second time. Mr. Pollard moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed. Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

- 9. INTERNATIONAL WHEAT AGREEMENT BILL 1953 .- Mr. McEwen (Minister for Commerce and Agriculture), pursuant to leave given on the 9th October, brought up a Bill intituled "A Bill for an Act to approve Acceptance by Australia of the Agreement Revising and Renewing the International Wheat Agreement", and moved, That it be now read a first time.
 - Question-put and passed.-Bill read a first time.

Mr. McEwen moved, by leave, That the Bill be now read a second time. Mr. Pollard moved, That the debate be now adjourned.

Question-That the debate be now adjourned-put and passed.

Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

10. CUSTOMS BILL 1953.—The Order of the Day having been read for the further consideration of this . Bill in Committee of the whole House-

- 11. LOAN (HOUSING) BILL 1953.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-
 - Debate resumed by Mr. Haylen who moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof :—" this House is of the opinion that the moneys should be advanced to the States but the Government should call an immediate conference of the parties to the State Housing Agreement (1945) and announce its intention of carrying out the Commonwealth's financial obligations under the Agreement and endeavour to secure an amendment to the Agreement which will enable tenants to buy their homes on easy terms, and which will secure a substantial reduction of the interest rate ".

Debate continued.

Mr. Whitlam was granted leave to continue his speech when the debate is resumed.

- Ordered-That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for the next sitting.
- 12. ADJOURNMENT.-Mr. Eric J. Harrison (Vice-President of the Executive Council) moved, That the House do now adjourn.

Question-put and passed.
