4. MESSAGE FROM THE SENATE .-- ESTATE DUTY ASSESSMENT BILL 1953.-- Mr. Speaker announced the receipt of the following Message from the Senate :---

The Senate returns to the House of Representatives the Bill for "An Act to amend the 'Estate Duty Assessment Act 1914-1950', as amended by the 'Taxation Administration Act 1953'", and acquaints the House that the Senate has agreed to the Bill with the Amendments indicated by the annexed Schedule, in which Amendments the Senate requests the concurrence of the House of Representatives.

- ; and (b) by adding at the end thereof the following sub-section :-(3.) In this section, "widow" includes widower."."

On the motion of Sir Arthur Fadden (Treasurer), the Amendments were agreed to, after debate. Resolution to be reported.

 - (3) the amounts of permissible income and permissible property under the means test to be further increased in accord with the change in money values;
