(a) they are claimed, in writing, by the person entitled to them ; and

(b) the duty, expenses of removal, warehouse rent and charges and other storage charges

(if any) on or in respect of them are paid,

they may be sold by the Collector.”.

Clause, as amended, agreed to.

Title agreed to.

Bill to be reported with an amendment.
