1. The House met, at half-past two o'clock p.m., pursuant to adjournment.-Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.

2. CENSURE MOTION .--- Mr. Evatt (Leader of the Opposition) moved, pursuant to notice, That this House censures the Government for its failure to establish a national economic plan to halt inflation and to ensure full and continuous employment; for its persistent neglect to bring in measures to prevent profiteering and for its refusal to accept national responsibility by seeking from the respective States, or from the people, adequate constitutional power to regulate prices, interest rates and capital issues : while, at the same time, denying to the States sufficient funds to meet their basic needs, especially in relation to homes, schools, hospitals and transport. Such failures of the Government have resulted in soaring prices and serious reductions of the living standards of the Australian people, particularly wage and salary earners, pensioners and all those dependent on small fixed incomes.
