The Report was read by the Clerk as follows:-

REPORT.

The Printing Committee has the honour to report that it has met in Conference with the Printing Committee of the Senate.

The Joint Committee, having considered the Petitions and Papers presented to Parliament since the last meeting of the Committee, and other Papers, motions for the printing of which lapsed with the close of the Session in March last, recommend that the following be printed:—

Australia, 1956: An Economic Survey.

Documents relating to the simultaneous dissolution of the Senate and the House of Representatives by His Excellency the Governor-General on 19th March, 1951.
