- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.
- 2. Petitions.—Mr. Cairns presented a Petition from certain citizens of Australia praying that immediate consideration be given to the matter of increasing the rate of age, invalid and widows' pensions to at least 50 per cent. of the basic wage.

Petition received and read.

Petitions from certain citizens of Australia praying that immediate consideration be given to the matter of increasing the rate of age, invalid and widows' pensions to at least 50 per cent. of the basic wage were presented by Mr. Crean, Mr. R. W. Holt and Mr. Bostock.

Petitions severally received.

Mr. Lucock presented a Petition from certain electors in the States of New South Wales, Queensland, Victoria, Tasmania and South Australia praying that funds made available for educational purposes be used for the extension of the public school system which not only gives a high standard of general education to all children but also makes provision for scripture teaching in its curriculum. Petition received and read.

- 3. MINISTERIAL ARRANGEMENTS.—Mr. Menzies (Prime Minister) informed the House that during the absence abroad of Mr. Casey, he would act as Minister for External Affairs and would exercise a general responsibility for external affairs policy, and that Mr. Osborne (Minister for Air) would attend to administrative details. The Commonwealth Scientific and Industrial Research Organization would be administered by Mr. H. E. Holt (Minister for Labour and National Service).
- PAPER.—The following Paper was presented, pursuant to Statute—

- 5. Leave of Absence to Member.—Sir Arthur Fadden (Treasurer) moved, That leave of absence for two months be given to the honorable Member for Gippsland (Mr. Bowden) on the ground of Parliamentary business overseas.

Question-put and passed.

6. Leave of Absence to Members.—Mr. H. E. Holt (Minister for Labour and National Service) moved, That leave of absence for two months be given to the Minister for External Affairs (Mr. Casey) on the ground of public business overseas, to the honorable Member for Mitchell (Mr. Wheeler) on the ground of Parliamentary business overseas, and to the honorable Member for North Sydney (Mr. Jack) owing to his absence from Australia.

Question-put and passed.

- 7. Leave of Absence to Members.—Mr. Evatt (Leader of the Opposition) moved, That leave of absence be given for two months to the honorable Members for Blaxland (Mr. Harrison) and Lalor (Mr. Pollard) on the ground of Parliamentary business overseas, to the honorable Members for Banks (Mr. Costa) and Newcastle (Mr. Watkins) on the ground of ill health, and for one month to the honorable Member for Wilmot (Mr. Duthie) on the ground of ill health. Question—put and passed.
- 8. Precedence to Government Business.—Mr. H. E. Holt (Minister for Labour and National Service) moved, pursuant to notice, That Government Business shall take precedence over General Business to-morrow.

Question-put and passed.

10. Commonwealth Grants Commission Bill 1957.—Mr. Townley (Minister for Immigration) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the Commonwealth Grants Commission Act 1933-1951, and for purposes connected with the amendment.

Question—put and passed.

Mr. Townley then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Townley moved, by leave, That the Bill be now read a second time.

Debate adjourned (Mr. Calwell), and the resumption of the debate made an Order of the Day for the next sitting.

11. NATIONAL CAPITAL DEVELOPMENT COMMISSION BILL 1957.—Mr. Fairhall (Minister for the Interior) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to establish a Commission for the Development of the City of Canberra as the National Capital of the Commonwealth, and for related purposes.

Question-put and passed.

Mr. Fairhall then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Fairhall moved, by leave, That the Bill be now read a second time.

Debate adjourned (Mr. J. R. Fraser), and the resumption of the debate made an Order of the Day for a later hour this day.

12. WAYS AND MEANS—WINE GRAPES CHARGES.—The House according to Order, resolved itself into the Committee of Ways and Means.

(In the Committee).

Mr. McMahon (Minister for Primary Industry) moved, That, in lieu of the maximum rate imposed by the Wine Grapes Charges Act 1929-1954, the maximum rate of charge on all grapes delivered to a winery or distillery on or after the first day of January, One thousand nine hundred and fifty-eight, for use in the manufacture of wine be—

(a) in respect of fresh grapes—Fifteen shillings per ton; and

(b) in respect of dried grapes—Two pounds five shillings per ton.

Question—put and passed.

Resolution to be reported, and leave asked to sit again.

The House resumed; Mr. Adermann reported accordingly.

Resolved—That the House will, at a later hour this day, again resolve itself into the said Committee.

Debate adjourned (Mr. Calwell), and the resumption of the debate made an Order of the Day for a later hour this day.
