- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.

- 4. DISCUSSION OF MATTER OF URGENCY—COMMONWEALTH HANDLING EQUIPMENT POOL.—Mr. O'Connor having proposed to Mr. Speaker that a definite matter of urgent public importance be submitted to the House for discussion, namely, "The action of the Government in disposing of the Commonwealth Handling Equipment Pool "—

Mr. Speaker called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly—

Mr. O'Connor addressed the House.

- No. 3.—Page 8, clause 25, sub-clause (2.), paragraph (d), lines 34 to 36, leave out all words after " planners " (first occurring), insert ", who may be selected from a list of town planners submitted to the
  - Minister by The Town Planning Institute of Australia; and ".

No. 4.—Page 9, clause 25, lines 5 to 9, leave out sub-clause (6.). On the motion of Mr. Fairhall (Minister for the Interior), the Amendments were agreed to.
