4. WAYS AND MEANS—CUSTOMS TARIFF AMENDMENT (No. 5).—The House, according to Order, resolved itself into the Committee of Ways and Means.

Mr. Osborne (Minister representing the Minister for Customs and Excise) moved-

CUSTOMS TARIFF AMENDMENT (No. 5).

That the Schedule to the *Customs Tariff* 1933–1958, as proposed to be amended by Customs Tariff Proposals introduced into the House of Representatives on the fourteenth day of May, One thousand nine hundred and fifty-eight, be further amended as set out in the Schedule to these Proposals, and that on and after the fifteenth day of August, One thousand nine hundred and fifty-eight, at nine o'clock in the forenoon, reckoned according to standard time in the Australian Capital Territory, Duties of Customs be collected in pursuance of the *Customs Tariff* 1933–1958 as so amended.
