## TUESDAY, 5TH APRIL, 1960.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.
- 2. Deaths of the Paramount Ruler of Malaya and the King of Cambodia.—Mr. Menzies (Prime Minister) referred to the deaths, since the House last met, of His Majesty the Paramount Ruler of Malaya and His Majesty the King of Cambodia and spoke of the esteem with which these Heads of State had been held in their respective countries. Mr. Menzies said that he was sure it would be the wish of all honorable Members if profound sympathy were conveyed to the Governments and countries of Malaya and Cambodia in the great losses which they had sustained.
  - Mr. Calwell (Leader of the Opposition) supported the remarks of the Prime Minister and joined in the expression of sympathy.
