In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to increase the Number of Judges who may be appointed to the Commonwealth Industrial Court.

Canberra, 28th April, 1960.
