Question—put and passed.

Resolution to be reported, and leave asked to sit again.

The House resumed; Mr. Bowden reported accordingly.

Ordered-That the House will, at a later hour this day, again resolve itself into the said Committee.

Mr. Holt moved, pursuant to contingent notice, That so much of the Standing Orders be suspended as would prevent the remaining stages being passed without delay.

Question-put and passed.

On the motion of Mr. Holt, the Resolution reported from the Committee was adopted by the House.

8. WAYS AND MEANS—FURTHER ADDITIONAL ESTIMATE 1959-60.—The House, according to Order, resolved itself into the Committee of Ways and Means.

(In the Committee.)

Mr. Holt (Treasurer) moved, That, towards making good the further additional Supply granted to Her Majesty for the service of the year 1959-60, there be granted out of the Consolidated Revenue Fund the sum of £10,000,000. Debate ensued.

Question—put and passed. Resolution to be reported, and leave asked to sit again.

The House resumed; Mr. Bowden reported accordingly. Ordered—That the House will, at a later hour this day, again resolve itself into the said Committee. On the motion of Mr. Holt, the Resolution reported from the Committee was adopted by the House. Ordered—That Mr. Holt and Mr. Adermann do prepare and bring in a Bill to carry out the foregoing Resolution and the Resolution adopted by the House on the 11th May in connexion with the Additional Estimates for 1959-60.

9. APPROPRIATION BILL (No. 2) 1959-60 [No. 2].—Mr. Holt (Treasurer) then brought up a Bill intituled "A Bill for an Act to grant and apply an additional sum out of the Consolidated Revenue Fund for the service of the year ending on the thirtieth day of June, One thousand nine hundred and sixty and to appropriate that sum".

Bill read a first time.

Mr. Holt moved, That the Bill be now read a second time.

- Debate adjourned (Mr. Calwell-Leader of the Opposition), and the resumption of the debate made an Order of the Day for a later hour this day.
- AIR NAVIGATION BILL 1960.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time— Debate resumed.

Debate resumed.

Question—put and passed.—Bill read a second time. The House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to. Bill to be reported without amendment.

The House resumed; Mr. Bowden reported accordingly. On the motion of Mr. Hulme (Minister for Supply), the House adopted the Report, and, by leave, the Bill was read a third time.

11. APPROPRIATION BILL (No. 2) 1959-60 [No. 2].—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time— Debate resumed.

Debate adjourned (Mr. Jess), and the resumption of the debate made an Order of the Day for the next sitting.

12. ADJOURNMENT.—Mr. Hulme (Minister for Supply), moved, That the House do now adjourn. Debate ensued.
