### TUESDAY, 15TH NOVEMBER, 1960.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. McLeay) took the Chair, and read Prayers.
- 2. RETURN TO WRIT—CALARE DIVISION.—Mr. Speaker announced that he had received a Return to the Writ which he had issued on the 4th October last for the election of a Member to serve for the Electoral Division of Calare, in the State of New South Wales, to fill the vacancy caused by the resignation of John Brooke Howse, Esquire, and that by the endorsement on the Writ, it was certified that John Armstrong England had been elected.

6. Message from the Governor-General.—Indus Basin Development Fund Agreement Bill 1960.— Mr. Speaker announced the receipt of the following Message from His Excellency the Governor-General:—

Message No. 42.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act relating to the Indus Basin Development Fund Agreement.

Canberra, 15th November, 1960.

Ordered-That the Message be taken into consideration, in Committee of the whole House, forthwith.

Question—put and passed.

Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Bowden reported accordingly.

On the motion of Mr. Osborne, the House adopted the Report, and the Bill was read a third time.

14. Excise Tariff Bill (No. 2) 1960.—Mr. Osborne (Minister representing the Minister for Customs and Excise) also brought up a Bill intituled "A Bill for an Act relating to Duties of Excise".

Bill read a first time.

Mr. Osborne moved. That the Bill be now read a second time.

Question-put and passed.-Bill read a second time.

The House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Bowden reported accordingly.

On the motion of Mr. Osborne, the House adopted the Report, and the Bill was read a third time.

15. Crimes Bill 1960.—The House, according to Order, resolved itself into a Committee of the Whole for the further consideration of the Bill.

(In the Committee.)

Clauses 1 to 4 agreed to.

Clause 5 debated.

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Bowden reported accordingly.

Ordered—That the House will, at a later hour this day, again resolve itself into the said Committee.

16. ECONOMIC MEASURES—MINISTERIAL STATEMENT—MOTION FOR PRINTING PAPER.—Mr. Holt (Treasurer) by leave, made a Ministerial Statement announcing measures decided upon by the Government to meet the present economic situation, and, by command of His Excellency the Governor-General, laid upon the Table the following Paper:—

Economic Measures—Ministerial Statement—

and moved, That the Paper be printed.

Suspension of Standing Orders—Extended time for speech.—Mr. Downer (Minister for Immigration) moved, by leave, That so much of the Standing Orders be suspended as would prevent Mr. Calwell (Leader of the Opposition) making his speech without limitation of time.

Question-put and passed.

Mr. Calwell moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof:—"this House declares that it has no confidence in the Government's capacity to guide the Australian economy efficiently and that the economic policies pursued by the Government over the past eleven years and in particular the measures announced to-night are an admission that the policy which the Government put into force in February last has proved a failure".

Debate continued.

Debate adjourned (Mr. Cash), and the resumption of the debate made an Order of the Day for the next sitting.

17. Message from the Senate,—A Message from the Senate was reported returning the following Bill without amendment:—

15th November, 1960—Message No. 55—Appropriation (Works and Services) 1960-61.

18. SALES TAX (EXEMPTIONS AND CLASSIFICATIONS) BILL (No. 2) 1960.—Mr. Holt (Treasurer) moved, by leave, That he have leave to bring in a Bill for an Act to amend the Sales Tax (Exemptions and Classifications) Act 1935-1959, as amended by the Sales Tax (Exemptions and Classifications) Act 1960.

Question—put and passed.

Bill brought up, and read a first time.

Mr. Holt moved, by leave, That the Bill be now read a second time.

Debate adjourned (Mr. Crean), and the resumption of the debate made an Order of the Day for the next sitting.

19. Ways and Means—Sales Tax.—The House, according to Order, again resolved itself into the Committee of Ways and Means.

(In the Committee.)

Mr. Holt (Treasurer) moved-

- 1. That, on and after the sixteenth day of November, One thousand nine hundred and sixty, the rate of sales tax in respect of goods covered by the Fifth Schedule to the Sales Tax (Exemptions and Classifications) Act be 40 per centum.
- 2. That, for the purposes of this resolution, "the Sales Tax (Exemptions and Classifications) Act "mean the Sales Tax (Exemptions and Classifications) Act 1935-1959, as proposed to be amended by the Sales Tax (Exemptions and Classifications) Bill 1960 and by the Sales Tax (Exemptions and Classifications) Bill (No. 2) 1960.

Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Lucock reported accordingly. Ordered—That the House will, at the next sitting, again resolve itself into the said Committee.

20. Adjournment.—Mr. Holt (Treasurer) moved, That the House do now adjourn. Question—put and passed.

And then the House, at two minutes past eleven o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
