10. Australia and the Common Market—Ministerial Statement—Motion for Printing Paper.—
Mr. Menzies (Prime Minister), by leave, made a Ministerial Statement informing the House of the nature of the action proposed or taken, and the issues involved, in the decision of the Government of Great Britain to negotiate for admission to the European Economic Community. Mr. Menzies then, by command of His Excellency the Governor-General, laid upon the Table the following Paper:—

Australia and the Common Market-Ministerial Statement-

and moved, That the Paper be printed.

Suspension of Standing Orders—Extended Time for Speech.—Mr. Townley (Minister for Defence) moved, by leave, That so much of the Standing Orders be suspended as would prevent Mr. Calwell (Leader of the Opposition) speaking for a period not exceeding 45 minutes.

Question—put and passed.

Mr. Calwell moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof:—"this House, while declaring that the United Kingdom's move to join the Common Market requires the strongest action to protect Australia's interests, expresses no confidence in this Government's ability to provide it because of its lack of foresight and frankness in this matter, its dilatoriness now, and its continuing failure, as demonstrated by the Prime Minister's speech, to appreciate the real issues which are involved".
