NATIONAL SERVICE TRAINING.—Sir Wilfrid Kent Hughes moved, pursuant to notice, That in view of the increasing pressure of Communist infiltration, subversion and guerilla aggression in South-East Asia, this House is of the opinion that, in order to strengthen the security of Australia, and South-East Asian countries who may desire assistance—
 - (i) National Service Training should be introduced on the basis of a minimum of twelve months continuous service, and
 - (ii) if it is considered advisable to establish such National Service Training on a selective basis, then rehabilitation benefits should be granted on similar, but not necessarily the same, lines as in the United States of America.
