7. MESSAGE FROM THE GOVERNOR-GENERAL—STATES GRANTS (UNIVERSITIES) BILL 1962.—Mr. Speaker announced the receipt of the following Message from His Excellency the Governor-General:—

DE L'ISLE, Governor-General.

Message No. 25.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the *States Grants* (Universities) Act 1960.

Canberra, 3rd May, 1962.

Ordered—That the Message be taken into consideration, in Committee of the whole House, forthwith.

#### (In the Committee.)

Mr. Menzies (Prime Minister) moved, That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the *States Grants (Universities) Act* 1960.

Question—put and passed. Resolution to be reported.

The House resumed; Mr. Lucock reported accordingly.

Mr. Menzies moved, pursuant to contingent notice, That so much of the Standing Orders be suspended as would prevent the remaining stages being passed without delay.

Question-put and passed.
