1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
2. RETURN TO WRIT—BATMAN DIVISION.—Mr. Speaker announced that he had received a Return to the Writ which he had issued on the 31st July last for the election of a Member to serve for the Electoral Division of Batman, in the State of Victoria, to fill the vacancy caused by the death of Alan Charles Bird, Esquire, and that by the endorsement on the Writ, it was certified that Samuel James Benson had been elected.
3. MEMBER SWORN.—Samuel James Benson, Esquire, was introduced, and made and subscribed the Oath required by law.
4. DEATH OF SENATOR M. W. POULTER.—Mr. Menzies (Prime Minister) referred to the death on the 2nd September of Senator M. W. Poulter, and moved, That this House expresses its deep regret at the death of Senator Maxwell William Poulter, a Senator for the State of Queensland, and tenders its profound sympathy to his widow and family in their bereavement.
