WEDNESDAY, 8TH MAY, 1963.

1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
2. QUESTIONS.—Questions without notice were answered.
3. DUMPING DUTIES—AGREEMENT BETWEEN AUSTRALIA AND NEW ZEALAND—MINISTERIAL STATEMENT—PRESENTATION OF PAPER—MOTION FOR PRINTING PAPER.—Mr. Fairhall (Minister representing the Minister for Customs and Excise), by leave, made a Ministerial Statement with reference to an agreement concerning dumping duties which had been concluded between the Governments of Australia and New Zealand, and, by command of His Excellency the Governor-General, laid upon the Table the following Paper:—
Copy of letter, dated 29th April, 1963, addressed by Senator Henty (Minister for Customs and Excise) to Mr. N. L. Shelton, New Zealand Minister for Customs, containing a copy of the Agreement on Dumping Duties concluded between the Governments of Australia and New Zealand—
and moved, That the Paper be printed.
Debate adjourned (Mr. Pollard), and the resumption of the debate made an Order of the Day for the next sitting.
4. PAPER.—The following Paper was presented, pursuant to Statute—
Public Service Act—Appointment—Postmaster-General's Department—G. W. Clark.
5. SUSPENSION OF STANDING ORDERS—INTERNATIONAL ORGANIZATIONS (PRIVILEGES AND IMMUNITIES) AND ASSOCIATED BILLS.—Sir Garfield Barwick (Minister for External Affairs) moved, by leave, That so much of the Standing Orders be suspended as would prevent—
(a) the consideration together of Notices of Motion Nos. 1 to 5;
(b) in relation to the proceedings on the following Bills, viz.:—International Organizations (Privileges and Immunities) Bill 1963, International Development Association Bill 1963, International Finance Corporation Bill 1963, International Monetary Agreements Bill 1963, and World Health Organization Bill 1963, the introduction of the Bills together, and one motion being moved without delay and one question being put in regard to, respectively, the first readings, the second readings, the Committee's report stage, and the third readings, of all the Bills together, and
(c) the consideration of all the Bills as a whole together in a Committee of the Whole.
Question—put and passed.
6. INTERNATIONAL ORGANIZATIONS (PRIVILEGES AND IMMUNITIES), INTERNATIONAL DEVELOPMENT ASSOCIATION, INTERNATIONAL FINANCE CORPORATION, INTERNATIONAL MONETARY AGREEMENTS, AND WORLD HEALTH ORGANIZATION BILLS 1963.—Sir Garfield Barwick (Minister for External Affairs) moved the following motions together, pursuant to notice:—
That he have leave to bring in a Bill for an Act relating to the Privileges and Immunities of certain International Organizations and of persons connected therewith, and for other purposes;
That he have leave to bring in a Bill for an Act to repeal section seven of the *International Development Association Act 1960*;
That he have leave to bring in a Bill for an Act to amend section six of the *International Finance Corporation Act 1955-1961*;
That he have leave to bring in a Bill for an Act to amend section eleven of the *International Monetary Agreements Act 1947*; and
That he have leave to bring in a Bill for an Act to amend section six of the *World Health Organization Act 1947*.
Question—put and passed.

Debate adjourned (Mr. Whitlam), and the resumption of the debate made an Order of the Day for the next sitting.
8. PARLIAMENTARY PAPERS BILL 1963.—Sir Garfield Barwick (Attorney-General) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the *Parliamentary Papers Act 1908–1946*.
Question—put and passed.
Bill brought up, and read a first time.
Sir Garfield Barwick moved, by leave, That the Bill be now read a second time.
Debate adjourned (Mr. Whitlam), and the resumption of the debate made an Order of the Day for the next sitting.
9. PROCESSED MILK PRODUCTS BOUNTY BILL 1963.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—
Debate resumed.
Question—put and passed.—Bill read a second time.
The House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to.
Bill to be reported without amendment.

The House resumed; Mr. Mackinnon reported accordingly.
On the motion of Mr. Adermann (Minister for Primary Industry), the House adopted the Report, and the Bill was read a third time.

10. INTERNATIONAL ORGANIZATIONS (PRIVILEGES AND IMMUNITIES), INTERNATIONAL DEVELOPMENT ASSOCIATION, INTERNATIONAL FINANCE CORPORATION, INTERNATIONAL MONETARY AGREEMENTS, AND WORLD HEALTH ORGANIZATION BILLS 1963.—Sir Garfield Barwick (Minister for External Affairs), pursuant to leave given this day, brought up together the Bills intitled:—
A Bill for an Act relating to the Privileges and Immunities of certain International Organizations and of persons connected therewith, and for other purposes;
