- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. Petitions.—Petitions from certain citizens of the Commonwealth praying that the Government remove section 127, and the words discriminating against aborigines in section 51, of the Commonwealth Constitution, by the holding of a referendum at an early date, were presented by Sir Robert Menzies (Prime Minister), Mr. Holt (Treasurer) and Mr. Mackinnon.

Petitions severally received.

Mr. James presented a Petition from certain electors of the Commonwealth praying that the pension increase of ten shillings proposed in the 1963 Budget be granted to all age, invalid and widow pensioners. Petition received and read.

Similar Petitions were presented by Mr. Cairns and Mr. Johnson, and were severally received.

Mr. Johnson also presented a Petition from certain electors of the Commonwealth praying that the Government (1) support the United Nations resolution for a Nuclear Test Ban Treaty, (2) ensure that foreign bases are not permitted on Australian soil and (3) in response to the call of the United Nations, declare Australia's willingness to enter into an agreement not to manufacture, test, station or acquire nuclear weapons.

- 10. REPATRIATION BILL 1963.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-Debate resumed.

Mr. Barnard moved, That the following new clause be inserted in the Bill:—

"2A. After section twenty-one of the Principal Act the following Part is inserted:—

'Part IIa.—Joint Committee on Repatriation.

'22.—(1.) As soon as conveniently practicable after the commencement of this Constitution Part, a Joint Committee of nine members of the Parliament, to be called the Joint of Committee. Committee on Repatriation, shall be appointed according to the practice of the Parliament with reference to the appointment of members to serve on Joint Committees of both Houses of the Parliament.

- (2.) Three of the members of the Committee shall be members of and appointed by the Senate, and six of the members of the Committee shall be members of and appointed by the House of Representatives.
- '22A. The members of the Committee shall hold office as a Joint Committee until Tenure of the House of Representatives for the time being expires by dissolution or effluxion of time. Office of members of the Committee may resign his seat on the Committee.

by writing under his hand addressed to the President of the Senate if he be a Senator, or to Resignation. the Speaker of the House of Representatives if he be a member of the House of Representatives.

- (2.) The seat of any member of the Committee shall be deemed to have become vacant if he ceases to be a Senator or a member of the House of Representatives (as the
- 22c. Where the seat of any member of the Committee becomes vacant, it shall be vacancies. filled by appointment according to the practice referred to in section twenty-two of this Act within fifteen sitting days after the happening of the vacancy if the House of the Parliament of which he is a member is then sitting, or, if not, then within fifteen sitting days after the next meeting of that House.

22D. There shall be a Chairman and a Vice-Chairman of the Committee, who shall Chairman and the Committee, who shall Chairman and the Committee who shall chair wh be elected by the members of the Committee at their first meeting, or as soon thereafter as is practicable.

22E. At any meeting of the Committee-

(a) five members shall form a quorum;

- (b) the Chairman or, in his absence, the Vice-Chairman or, in the absence of both the Chairman and the Vice-Chairman, a member elected by the members present, shall preside;
- (c) all questions shall be decided by a majority of the votes of the members present; and
- (d) the Chairman or other member presiding shall have a deliberative vote and, in the event of an equality of votes, shall also have a casting vote.
- ' 22F. The Committee may sit and transact business during any adjournment or recess as well as during the session, and may sit at such times (including times while either House during recess. of the Parliament is actually sitting) and in such places, and conduct their proceedings in such manner, as they deem proper.

'22G. The Committee shall have power to send for persons, papers and records. Power to '22H. The powers, privileges and immunities of the Committee and of its members persons, shall be those of each of the Houses of the Parliament and of its members and its papers and records. committees.
