### TUESDAY, 24TH SEPTEMBER, 1963.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.-Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. PETITION.-Mr. Johnson presented a Petition from certain citizens of the Commonwealth praying that the Government remove section 127, and the words discriminating against aborigines in section 51, of the Commonwealth Constitution, by the holding of a referendum at an early date. Petition received.
- 3. MINISTERIAL ARRANGEMENTS.-Sir Robert Menzies (Prime Minister) informed the House that, during the absence abroad of Mr. Holt, Senator Paltridge (Minister for Civil Aviation) would act as Treasurer and would be represented in this House by himself. Sir Robert Menzies also informed the House that during the absence of Mr. Davidson, owing to illness, Mr. Swartz (Minister for Repatriation) would reply to questions addressed to the Postmaster-General.
- 4. QUESTIONS .-- Questions without notice were answered.
- 5. PAPERS.—The following Papers were presented, pursuant to statute—

- 7. LOAN (HOUSING) BILL (No. 2) 1963.-The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-
  - Debate resumed by Mr. Whitlam who moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof:---" whilst not in any way opposing the passage of the Bill, the House expresses the view that the Government should give effect to the recommendation of the Conference of State Housing Ministers in Melbourne on the 19th March, 1963, that a Committee of Enquiry be established consisting of representatives of the Commonwealth Government and the State Governments to enquire into the anticipated increased housing requirements arising during the next five years".

Debate adjourned (Mr. Webb), and the resumption of the debate made an Order of the Day for the next sitting.

Debate continued.

- 8. ADJOURNMENT.—Mr. Swartz (Minister for Repatriation) moved, That the House do now adjourn. Question—put and passed.
- And then the House, at five minutes to eleven o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
