### TUESDAY, 7TH APRIL, 1964.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.-Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. ROYAL BIRTH—REPLY TO JOINT ADDRESS OF CONGRATULATION TO HER MAJESTY THE QUEEN.—Mr. Speaker informed the House that he had received from His Excellency the Governor-General the following reply by Her Majesty the Queen to the Joint Address presented on the occasion of the birth of a son:-"I have received with much pleasure the joint address from the Members of the Senate and the House of Representatives of the Commonwealth of Australia assembled in Parliament. Please convey to them the sincere thanks of my husband and myself for their congratulations on the birth of our third son and for the assurance of their loyalty.

3. DEATH OF GENERAL DOUGLAS MACARTHUR.-Sir Robert Menzies (Prime Minister) referred to the death on the 5th April of General Douglas A. MacArthur, Supreme Commander of the Allied Forces in the South-West Pacific during the last war, and spoke with gratitude of the outstanding services which General MacArthur had rendered to Australia.

Mr. Calwell (Leader of the Opposition) supported the remarks of the Prime Minister.

- 4. QUESTIONS .-- Questions without notice were asked.
- 5. PAPER.-The following paper was presented, pursuant to statute-
  - Public Works Committee Act-Twenty-eighth General Report of the Parliamentary Standing Committee on Public Works.
- 6. MESSAGE FROM THE GOVERNOR-GENERAL—ASSENT TO BILL.—A message from His Excellency the Governor-General was announced informing the House that His Excellency, in the name and on behalf of Her Majesty, had assented to the following Bill:-
  - 26th March, 1964—Message No. 5—Social Services 1964.
- 7. TASMANIA GRANT (GORDON RIVER ROAD) BILL 1964.-The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time-Debate resumed.

Question-put and passed.-Bill read a second time. Message from the Governor-General.-Mr. Speaker announced the receipt of message No. 6, dated 5th March, 1964, from His Excellency the Governor-General recommending an appropriation of revenue for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

- On the motion of Mr. Swartz (Minister for Repatriation), the Bill was read a third time.
- 8. POSTPONEMENT OF ORDERS OF THE DAY .- Ordered -- That orders of the day Nos. 2 to 9, government business, be postponed until a later hour this day.
- 9. CUSTOMS TARIFF, CUSTOMS TARIFF (CANADA PREFERENCE), CUSTOMS TARIFF (NEW ZEALAND PREFERENCE) (No. 1) AND CUSTOMS TARIFF (PAPUA AND NEW GUINEA PREFERENCE) BILLS 1964.—The House, according to order, resolved itself into a committee of the whole for the further consideration of the Bills.

(In the committee.)

Customs Tariff Bill 1964-First Schedule debated and agreed to. Second Schedule debated and agreed to. Third Schedule-Progress to be reported, and leave asked to sit again.

The House resumed; Mr. Lucock reported accordingly.

Ordered—That the House will, at a later hour this day, again resolve itself into the said committee. F.3911/64.

 MEAT INDUSTRY BILL 1964.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time— Debate resumed.

Debate adjourned (Mr. Gibbs), and the resumption of the debate made an order of the day for the next sitting.

- 11. ADJOURNMENT.—Mr. Adermann (Minister for Primary Industry) moved, That the House do now adjourn. Question—put and passed.
- And then the House, at twenty-six minutes to eleven o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
