1. The House met, at three o'clock p.m., according to the terms of the resolution of the 20th May last.
2. ABSENCE OF MR. SPEAKER.—The Clerk, at the Table, having informed the House that Mr. Speaker (the Honorable Sir John McLeay) was unavoidably absent, the Chairman of Committees (Mr. Lucock) took the Chair as Deputy Speaker, and read Prayers.
3. COMMISSION TO ADMINISTER OATH TO MEMBERS.—Mr. Deputy Speaker announced that he had received from His Excellency the Administrator of the Government of the Commonwealth the following Commission:—

His Excellency the Administrator of the Government of the Commonwealth of Australia.

To PHILIP ERNEST LUCOCK, Esquire, M.P., Deputy Speaker of the House of Representatives of the Commonwealth of Australia.

GREETING:

WHEREAS by section forty-two of the Constitution of the Commonwealth of Australia it is amongst other things enacted that every Member of the House of Representatives shall, before taking his seat, make and subscribe before the Governor-General, or some other person authorized by him, an Oath or Affirmation of Allegiance in the form set forth in the Schedule to the aforesaid Constitution:

AND WHEREAS by section four of the said Constitution it is provided amongst other things that the provisions of the said Constitution relating to the Governor-General extend and apply to such person as the Queen may appoint to administer the Government of the Commonwealth:

NOW THEREFORE I, SIR ERIC WINSLOW WOODWARD, the Administrator of the Government of the Commonwealth, do by these Presents command and authorize you from time to time, at Parliament House, Canberra, to administer the said Oath or Affirmation of Allegiance to such Members of the House of Representatives as have not already taken and subscribed the same since their election to the House of Representatives.

GIVEN under my Hand and the Great Seal of the Commonwealth of Australia, this eleventh day of August, One thousand nine hundred and sixty-four.

4. RETURNS TO WRITS—ANGAS AND PARRAMATTA DIVISIONS.—Mr. Deputy Speaker announced that he had received Returns to the Writs which Mr. Speaker had issued on the 8th May for the election of Members to serve for the Electoral Divisions of Angas, in the State of South Australia, and Parramatta, in the State of New South Wales, to fill the vacancies caused by the resignations of the Honorable Alexander Russell Downer and the Honorable Sir Garfield Edward John Barwick, Q.C., respectively. By the endorsement on the Writs, it was certified that Geoffrey O'Halloran Giles had been elected as the Member to serve for the Division of Angas and that Nigel Hubert Bowen had been elected as the Member to serve for the Division of Parramatta.
5. MEMBERS SWORN.—Geoffrey O'Halloran Giles and Nigel Hubert Bowen were introduced, and in turn made and subscribed the oath required by law.

6. **DEATH OF PRIME MINISTER OF INDIA (JAWAHARLAL NEHRU).**—Sir Robert Menzies (Prime Minister) referred to the death, on the 27th May, 1964, of the Prime Minister of India (Jawaharlal Nehru), and moved, That this House records its sincere regret at the death of Jawaharlal Nehru, Prime Minister of India, places on record its admiration for his devotion to and achievements on behalf of the people of his own country, and for his unceasing and positive interest in international affairs, expresses to the people of India its profound regret at the loss they have suffered, and tenders its deep sympathy to his relatives. And Mr. Calwell (Leader of the Opposition) having seconded the motion, and Mr. McEwen (Minister for Trade and Industry) having addressed the House in support thereof, and all Members present having risen, in silence—
Question—passed.
7. **DEATH OF THE RIGHT HONORABLE SIR JOHN LATHAM.**—Sir Robert Menzies (Prime Minister) referred to the death, on the 25th July, 1964, of the Right Honorable Sir John Latham, and moved, That this House expresses its deep regret at the death of the Right Honorable Sir John Greig Latham, G.C.M.G., formerly a Member of this House for the Division of Kooyong, Minister of the Crown, Leader of the Opposition and Chief Justice of the High Court of Australia, places on record its appreciation of his long and distinguished public service and tenders its profound sympathy to his relatives in their bereavement. And Mr. Calwell (Leader of the Opposition) having seconded the motion, and Mr. McEwen (Minister for Trade and Industry) having addressed the House in support thereof, and all Members present having risen, in silence—
Question—passed.
8. **DEATH OF THE HONORABLE C. W. FROST.**—Sir Robert Menzies (Prime Minister) referred to the death, on the 22nd July, 1964, of the Honorable C. W. Frost, and moved, That this House expresses its deep regret at the death of the Honorable Charles William Frost, a former Member of this House for the Division of Franklin, and a former Minister of the Crown, places on record its appreciation of his long and meritorious public service and tenders its profound sympathy to his widow and family in their bereavement. And Mr. Calwell (Leader of the Opposition) having seconded the motion, and Mr. McEwen (Minister for Trade and Industry) and Mr. Falkinder having addressed the House in support thereof, and all Members present having risen, in silence—
Question—passed.
9. **DEATHS OF MR. J. O. CRITCHLEY, MR. R. WARDLAW, MR. R. E. CLOTHIER AND MR. D. J. CAMERON.**—Sir Robert Menzies (Prime Minister) referred to the deaths of three former Senators, Mr. John Owen Critchley, Mr. Robert Wardlaw and Mr. Robert Ernest Clothier, and a former Member of this House for the Division of Lilley, Mr. Donald James Cameron, and paid tribute to their memory. Mr. Calwell (Leader of the Opposition), Mr. McEwen (Minister for Trade and Industry) and Mr. K. M. K. Cairns joined in the expression of sympathy.
10. **THE LATE PRESIDENT OF THE UNITED STATES OF AMERICA (MR. JOHN F. KENNEDY).**—Mr. Deputy Speaker informed the House that a communication had been received from the President of the United States of America (Mr. Lyndon B. Johnson) conveying the thanks of the American people to the House for its resolution of sympathy in connexion with the death of President John F. Kennedy.
11. **PETITIONS.**—Mr. Beaton presented a petition from certain electors of the Commonwealth praying that the Commonwealth Government immediately grant a basic pension rate of £8 10s. per week, formulate a national housing plan for low rental homes for pensioners and provide all pensioners within the permissible income with the medical entitlement card.
Petition received and read.
Similar petitions were presented by Mr. Benson, Mr. Peters and Mr. Jess, and were severally received. Mr. Killen presented a petition from certain electors of the Commonwealth praying that the Commonwealth Government (1) instruct its representative at the United Nations to condemn the French Government's proposal to test nuclear weapons in the Pacific, (2) again protest directly to the French Government with a view to cancellation of the tests and (3) use all appropriate means at its disposal to obtain an extension to the treaty to cover underground tests.

12. **MINISTERIAL CHANGES AND ARRANGEMENTS.**—Sir Robert Menzies (Prime Minister) informed the House of the following ministerial changes which had taken place since the last meeting of the House:—
Senator Sir William Spooner had resigned from the Ministry with effect from the 10th June leaving vacant the positions of Minister for National Development, Vice-President of the Executive Council and Leader of the Government in the Senate.
Senator Paltridge (Minister for Defence) had relinquished the portfolio of Minister for Civil Aviation and had been appointed Leader of the Government in the Senate.
Senator Henty had resigned as Minister for Customs and Excise and had been appointed Minister for Civil Aviation and Deputy Leader of the Government in the Senate.
Mr. Fairbairn had resigned as Minister for Air and had been appointed Minister for National Development.
Mr. Howson had been appointed Minister for Air and Senator Anderson Minister for Customs and Excise.
Mr. McMahon (Minister for Labour and National Service) had been appointed Vice-President of the Executive Council.
Mr. Hulme (Postmaster-General) and Mr. Fairbairn had been included in the Cabinet.

Sir Robert Menzies stated that the representation of Ministers had been varied as follows:—

In this House—Mr. Bury (Minister for Housing) would represent the Minister for Customs and Excise.

In the Senate—

Senator Paltridge would represent the Prime Minister (except in matters relating to education and research), the Minister for National Development and the Minister for Housing in addition to representing the Minister for Shipping and Transport.

Senator Henty would represent the Minister for Trade and Industry and the Treasurer in addition to representing the Ministers for the Army and the Navy.

Senator Gorton (Minister for Works) would represent the Minister for Territories in addition to representing the Minister for External Affairs, the Minister for Labour and National Service and the Attorney-General, and would continue to deal with matters arising relating to education and research.

Senator Anderson would represent the Ministers for Supply, Immigration, Social Services and Repatriation.
