WEDNESDAY, 2ND SEPTEMBER, 1964.

1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—The Deputy Speaker (Mr. Lucock) took the Chair, and read Prayers.
2. QUESTIONS.—Questions without notice were asked.
3. PAPERS.—The following papers were presented, pursuant to statute—
Nationality and Citizenship Act—Return for year 1963–64.
Science and Industry Research Act—Commonwealth Scientific and Industrial Research Organization—Sixteenth Annual Report, for year 1963–64.
4. LEAVE OF ABSENCE TO MEMBERS.—Mr. Hasluck (Minister for External Affairs) moved, That leave of absence for one month be given to the Speaker (Sir John McLeay) and the honorable Member for Henty (Mr. Fox) on the ground of Parliamentary business overseas.
Question—put and passed.
5. LEAVE OF ABSENCE TO MEMBERS.—Mr. McEwen (Minister for Trade and Industry) moved, That leave of absence for one month be given to the honorable Members for Gwydir (Mr. Allan) and Wimmera (Mr. King) on the ground of Parliamentary business overseas.
Question—put and passed.
6. LEAVE OF ABSENCE TO MEMBERS.—Mr. Calwell (Leader of the Opposition) moved, That leave of absence for one month be given to the honorable Members for Darebin (Mr. Courtney) and Wills (Mr. Bryant) on the ground of Parliamentary business overseas, and to the honorable Member for Eden-Monaro (Mr. A. D. Fraser) owing to his absence from Australia.

9. REPATRIATION BILL 1964.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time—
Debate resumed.
Question—put and passed.—Bill read a second time.
The House resolved itself into a committee of the whole.

Proposed new clauses—

Mr. Barnard moved, That the following new clause be inserted in the Bill:—

“2A. After section twenty-one of the Principal Act the following Part is inserted:—

‘PART II A.—JOINT COMMITTEE ON REPATRIATION.

‘22.—(1.) As soon as conveniently practicable after the commencement of this Constitution Part, a Joint Committee of nine members of the Parliament, to be called the Joint Committee on Repatriation, shall be appointed according to the practice of the Parliament with reference to the appointment of members to serve on Joint Committees of both Houses of the Parliament.

(2.) Three of the members of the Committee shall be members of and appointed by the Senate, and six of the members of the Committee shall be members of and appointed by the House of Representatives.

‘22A. The members of the Committee shall hold office as a Joint Committee until the House of Representatives for the time being expires by dissolution or effluxion of time.

‘22B.—(1.) Any member of the Committee may resign his seat on the Committee by writing under his hand addressed to the President of the Senate if he be a senator, or to the Speaker of the House of Representatives if he be a member of the House of Representatives.

(2.) The seat of any member of the Committee shall be deemed to have become vacant if he ceases to be a senator or a member of the House of Representatives (as the case may be).

‘22C. Where the seat of any member of the Committee becomes vacant, it shall be filled by appointment according to the practice referred to in section twenty-two of this Act within fifteen sitting days after the happening of the vacancy if the House of the Parliament of which he is a member is then sitting, or, if not, then within fifteen sitting days after the next meeting of that House.

‘22D. There shall be a Chairman and a Vice-Chairman of the Committee, who shall be elected by the members of the Committee at their first meeting, or as soon thereafter as is practicable.

‘22E. At any meeting of the Committee—

(a) five members shall form a quorum;

(b) the Chairman or, in his absence, the Vice-Chairman or, in the absence of both the Chairman and the Vice-Chairman, a member elected by the members present, shall preside;

(c) all questions shall be decided by a majority of the votes of the members present; and

(d) the Chairman or other member presiding shall have a deliberative vote and, in the event of an equality of votes, shall also have a casting vote.

Quorum and procedure at meetings.

‘22F. The Committee may sit and transact business during any adjournment or recess as well as during the session, and may sit at such times (including times while either House of the Parliament is actually sitting) and in such places, and conduct their proceedings in such manner, as they deem proper.

Power to sit during recess.

‘22G. The Committee shall have power to send for persons, papers and records.

‘22H. The powers, privileges and immunities of the Committee and of its members shall be those of each of the Houses of the Parliament and of its members and its committees.

Powers, privileges and immunities of Committee.

‘22J. The Committee shall examine the Repatriation Act and regulations and, in a report to the Parliament, recommend amendments necessary to be made in the Act and regulations to remove existing anomalies and improve their provisions.”.

Functions of Committee.

“ 2B. Section thirty-seven of the Principal Act is amended—

(a) by inserting in sub-section (1.), after the words ‘ pulmonary tuberculosis ’, ^{Pension for} _{pulmonary} _{tuberculosis.}
the words ‘ or cancer ’; and

(b) by omitting from paragraph (b) of sub-section (3.) the words ‘ pulmonary tuberculosis ’ and inserting in their stead the words ‘ pulmonary tuberculosis or cancer ’.”.
