### WEDNESDAY, 28TH OCTOBER, 1964.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. Petition.—Mr. Killen presented a petition from certain citizens of the Commonwealth urging that the Australian Government (a) investigate the reported worsening of the food situation in India to ascertain the type and amount of aid which Australia could offer to relieve the present crisis and (b) negotiate with the Indian Government to ascertain the type and amount of additional aid and trade which Australia could offer, on a long term basis, to help in the development of India.

  - (b) the consideration of the Bills in one committee of the whole.Question—put and passed.

7. PARLIAMENTARY ALLOWANCES, MINISTERS OF STATE (No. 2), AND PARLIAMENTARY RETIRING ALLOWANCES Bills 1964.—Sir Robert Menzies (Prime Minister) presented the following Bills:—

A Bill for an Act relating to Parliamentary Allowances;

A Bill for an Act relating to the Salaries and Allowances of the Ministers of State; and

A Bill for an Act relating to Parliamentary Retiring Allowances.

Bills together read a first time.

Sir Robert Menzies moved, That the Bills be now read a second time.

Debate ensued.

Question—put and passed.—Bills together read a second time.

Messages from the Deputy of the Governor-General.—Mr. Speaker announced the receipt of the following messages from His Excellency the Deputy of the Governor-General recommending an appropriation of revenue for the purposes of the Bills, viz.:-

No. 45, dated 26th October, 1964—Parliamentary Allowances Bill 1964; No. 46, dated 26th October, 1964—Ministers of State Bill (No. 2) 1964; and

No. 47, dated 22nd October, 1964-Parliamentary Retiring Allowances Bill 1964.

Leave granted for third readings to be moved forthwith.

Sir Robert Menzies moved, That the Bills be now read a third time.

Debate ensued.

8. SALARIES (STATUTORY OFFICES) ADJUSTMENT BILL 1964.—Sir Robert Menzies (Prime Minister), by leave, presented a Bill for an Act to increase the Salaries payable to the Holders of certain Statutory Offices. Bill read a first time.

Sir Robert Menzies moved, That the Bill be now read a second time.

Debate, by leave, ensued.

Question—put and passed.—Bill read a second time.

Message from the Deputy of the Governor-General.—Mr. Speaker announced the receipt of message No. 48, dated 26th October, 1964, from His Excellency the Deputy of the Governor-General recommending an appropriation of revenue for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

On the motion of Sir Robert Menzies, the Bill was read a third time.

- 9. PRECEDENCE TO GOVERNMENT BUSINESS .-- Mr. Adermann (Minister for Primary Industry) moved, pursuant to notice, That government business shall take precedence over general business to-morrow. Question-put and passed.
- 10. MIGRATION BILL 1964.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time-

Debate resumed.

Question—put and passed.—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr. Opperman (Minister for Immigration), the Bill was read a third time.
