### THURSDAY, 12TH NOVEMBER, 1964.

- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. CONGRATULATIONS TO MR. SPEAKER.—Sir Robert Menzies (Prime Minister) referred to the fact that Mr. Speaker's term of office as Speaker had this day equalled the record term of office of Sir Frederick Holder during the period 1901-1909. Sir Robert Menzies thanked Mr. Speaker for his services to the House and extended his congratulations.
  - Mr. Calwell (Leader of the Opposition), Mr. Adermann (Minister for Primary Industry), and other honorable Members supported the remarks of the Prime Minister.
  - Mr. Speaker expressed his appreciation of the kindly references to his services.
- 3. QUESTIONS.—Questions without notice were asked.
- 4. PAPERS.—The following paper was presented, by command of His Excellency the Governor-General— Northern Territory—Report for year 1962-63.

Units, Broadmeadows.—Mr. Freeth (Minister representing the Minister for Works) moved, pursuant to notice, That, in accordance with the provisions of the Public Works Committee Act 1913-1960, the following proposed work be referred to the Parliamentary Standing Committee on Public Works for investigation and report:—Construction of Permanent Barracks and Depot Accommodation at Broadmeadows, Victoria, for A.R.A. Units.

Mr. Freeth presented plans in connexion with the proposed work. Question—put and passed.

10. Housing Loans Insurance Bill 1964.—Mr. Bury (Minister for Housing), pursuant to notice, presented a Bill for an Act to make provision with respect to Insurance against Losses arising out of the making of Loans for the purpose of financing Housing.

Bill read a first time.

Mr. Bury moved, That the Bill be now read a second time.

Debate adjourned (Mr. Crean), and the resumption of the debate made an order of the day for the next sitting.

- 12. Advance to the Treasurer 1963-64—Statement of Expenditure.—The House, according to order, resolved itself into a committee of the whole to consider the statement.

Mr. Holt (Treasurer) moved, That the following resolution be reported to the House:-

That the committee agrees with the statement for the year 1963-64 of heads of expenditure and the amounts charged thereto pursuant to section 36A of the Audit Act 1901-1962.

Question—put and passed.

The House resumed; Mr. Failes reported accordingly.

On the motion of Mr. Holt, the resolution reported from the committee was adopted by the House.

13. Loan (Airlines Equipment) Bill 1964.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time—

Debate resumed by Mr. Crean who moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof:—"this House, whilst not declining to give the Bill a second reading, is of opinion that the financing of the purchase of aircraft by the Australian National Airlines Commission and Qantas Empire Airways Limited should be met from revenue and not from a loan raised overseas".

Debate continued.

Question—That the words proposed to be omitted stand part of the question—put.

Debate adjourned (Mr. Allan), and the resumption of the debate made an order of the day for the next
