- 2. DEATH OF THE PRINCESS ROYAL—REPLY TO ADDRESS OF CONDOLENCE.—Mr. Speaker informed the House that the following reply to the Address of Condolence to Her Majesty the Queen had been received from His Excellency the Governor-General:—

29th April, 1965.

Dear Mr. Speaker,

The Address from the Speaker and the Members of the House of Representatives on the occasion of the death of Her Royal Highness The Princess Royal has been laid before Her Majesty The Queen.

I am commanded to convey to you Mr. Speaker and to the Members of the House Her Majesty's heartfelt thanks. The Queen is deeply sensible of the expressions of sympathy by the elected representatives of her people throughout the Commonwealth of Australia at a time when Her Majesty and her family were suffering from a sad and unexpected loss.
