- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. QUESTIONS.—Questions without notice were asked.
- 3. ALTERATION OF DAY OF NEXT MEETING.—Mr. McMahon (Minister for Labour and National Service)moved, That the House, at its rising, adjourn until to-morrow at half-past nine o'clock a.m. Question—put and passed.
- 4. YIRRKALA ABORIGINES—SELECT COMMITTEE RECOMMENDATIONS.—Mr. Beazley moved, pursuant to notice, That in the opinion of this House the recommendations set out in paragraphs 76 and 79 of the Report of the Select Committee on the Grievances of Yirrkala Aborigines, Arnhem Land Reserve, should be implemented.

Debate ensued.

It being two hours after the time fixed for the meeting of the House, the debate was interrupted in accordance with standing order 109.

Ordered—That the time for the discussion of notices be extended until fifteen minutes to one o'clock p.m. Debate continued.

The time allotted for precedence to general business having expired, the debate was interrupted, Mr. Cleaver was granted leave to continue his speech when the debate is resumed, and the resumption of the debate was made an order of the day for the next sitting.

5. Universities (Financial Assistance) Bill (No. 2) 1965.—Sir Robert Menzies (Prime Minister), pursuant to notice, presented a Bill for an Act to amend the *Universities* (Financial Assistance) Act 1963-1964, as amended by the *Universities* (Financial Assistance) Act 1965.

Bill read a first time.

Sir Robert Menzies moved, That the Bill be now read a second time.

Debate adjourned (Mr. Crean), and the resumption of the debate made an order of the day for the next sitting.

6. Melbourne (Tullamarine) Airport—Works for terminal complex, &c.—Approval of work.—Mr. Freeth (Minister representing the Minister for Works) moved, pursuant to notice, That, in accordance with the provisions of the *Public Works Committee Act* 1913–1960, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the Committee has duly reported to this House:—Provision of buildings and services to terminal complex, control and equipment building, D.C.A. maintenance area, fire station, &c., at Melbourne (Tullamarine) Airport.

Debate ensued.

Question-put and passed.

- NATIVE MEMBERS OF THE FORCES BENEFITS BILL 1965.—The order of the day having been read for the second reading—Mr. Swartz (Minister representing the Minister for Repatriation) moved, That the Bill be now read a second time.
 - Debate adjourned (Mr. Pollard), and the resumption of the debate made an order of the day for the next sitting.
- CURRENCY BILL 1965.—The House, according to order, resolved itself into a committee of the whole for the further consideration of the Bill.

Clause 18-

On the motion of Mr. Holt (Treasurer), the following amendment was made:—

Page 6, omit sub-clause (2.), insert the following sub-clause:-

- "(2.) Section 10 of this Act does not, before the date fixed by Proclamation in pursuance of section 21 of this Act, apply in relation to-
 - (a) a reference to an amount of money in the currency provided for by the repealed Acts in a security for money, contract, agreement, deed or other instrument executed or entered into in pursuance of the last preceding sub-section; or
 - (b) a reference in any other manner to an amount of money in the currency provided for by the repealed Acts, being a reference made in pursuance of that sub-section.".

Clause, as amended, agreed to.

Clause 19-

On the motion of Mr. Holt, the following amendment was made:—

Page 6, omit sub-clause (1.), insert the following sub-clause:-

"(1.) For the purpose of making, in the currency provided for by this Act, a payment—

- (a) that is payable in pursuance of, under or by virtue of a sale or a security for money, or any other contract, agreement, deed, instrument, transaction, dealing, matter or thing made, executed, entered into or done in pursuance of sub-section (1.) of the last preceding section; and
- (b) that-

(i) is made by a bill of exchange or promissory note; or

(ii) is not so made but was payable before the date fixed in pursuance of section 21 of this Act and is not made until after that date,

the amount of money in the currency provided for by this Act that corresponds to an amount of money in the currency provided for by the repealed Acts is, subject to the next succeeding sub-section, an amount calculated on the basis of the equivalents specified in sub-section (4.) of section 8 of this Act.".

Clause, as amended, agreed to.

Clause 20-

On the motion, by leave, of Mr. Holt, the following amendments were made together:—
Page 7, line 35, omit "Notwithstanding", insert "Subject to sub-section (6A.) of this section and notwithstanding".

Page 7, lines 44 and 45, omit "Notwithstanding the preceding provisions of this section", insert Subject to the next succeeding sub-section and notwithstanding the preceding provisions of this section, for the purpose of making, before the date fixed in pursuance of section 21 of this Act, a payment that is referred to in paragraph (a) of sub-section (1.) of the last preceding section ".

Page 8, after sub-clause (6.) insert the following sub-clause:-"(6A.) The last two preceding sub-sections do not apply in relation to a payment for the remuneration of an employee whether the remuneration is by way of salary, wages, commission or otherwise.".

Clause, as amended, agreed to.

Clause 21-

On the motion, by leave, of Mr. Holt, the following amendments were made together:—Page 8, line 18, before "section" insert "sub-section (1.) of".

Page 8, line 21, omit "section 18 of this Act", insert "that sub-section".

Clause, as amended, agreed to.

Clauses 22 and 23, by leave, taken together, and agreed to.

Clause 24

On the motion of Mr. Holt, the following amendment was made:—

Page 9, at the end of the clause add the following sub-clause:-

(2.) Notwithstanding any provision of the Bills of Exchange Act 1909-1958, a cheque may be presented for payment by a banker (including the banker on whom that cheque is drawn) on any of the days referred to in the last preceding sub-section.".

Clause, as amended, agreed to.

Remainder of Bill, by leave, taken as a whole, and agreed to.

Bill, as amended, agreed to.

Bill to be reported with amendments.

The House resumed; Mr. Lucock reported accordingly.

On the motion of Mr. Holt, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

"(1.) The Board shall consist of thirteen members, namely:-

(a) one member to represent the Commonwealth;

- (b) one member to represent the State of New South Wales;
- (c) one member to represent the State of Victoria;
- (d) one member to represent the State of Queensland; (e) two members to represent tobacco growers in the State of New South Wales;
- (f) two members to represent tobacco growers in the State of Victoria;
- (g) two members to represent tobacco growers in the State of Queensland;
- (h) one other member to represent tobacco growers; and
- (i) two members to represent tobacco manufacturers.".
