- 3. DIPLCMATIC RELATIONS WITH YUGOSLAVIA—MINISTERIAL STATEMENT.—Mr. Hasluck (Minister for External Aflairs), by leave, informed the House that the Government and the Government of Yugoslavia had agreed to establish diplomatic relations and to exchange ambassadors.
- 4. DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—EDUCATION—TEACHER AND CLASSROOM SHORTAGE.— MI. Speaker informed the House that Mr. Reynolds had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The failure of the Government to recognise the critical shortage of qualified teachers and classroom accommodation in schools throughout Australia and its Territories and its refusal to implement important recommendations of the Martin Committee, recent Premiers' Conferences and the Australian Education Council designed to alleviate these conditions ".

The proposed discussion having received the necessary support— Mr. Reynolds addressed the House. Discussion ensued. Discussion concluded.
