- 1. The House met, at half past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. Petition.—Mr. Bosman presented a petition from certain citizens of the Electoral Division of St. George praying that particular steps be taken by the Commonwealth Government to lessen the noize hazard emanating from aircraft using Sydney Kingsford-Smith Airport.

- 3. QUESTIONS.—Questions without notice were asked.
- 4. Papers.—The following papers were presented, by command of His Excellency the Governor-General—Communist China Foreign Ministry—Statement relating to Russian aid to Vietnam published in the Daily News Release, dated 4th May, 1966, of the Hsinhua News Agency.

  Foreign Affairs—Joint Committee—Paper on the United Nations prepared by the Committee.
- 5. NORTHERN TERRITORY ORDINANCES—WITHHOLDING OF ASSENT—STATEMENTS OF REASONS—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPERS.—Mr. Barnes (Minister for Territories), by leave, made a ministerial statement with reference to the withholding of assent to the Local Government Ordinance 1965 and the Agricultural Development Leases Ordinance 1965 which had been passed by the Legislative Council for the Northern Territory. Mr. Barnes then presented, pursuant to statute, the following papers:—
