- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr. Speaker (the Honorable Sir John McLeay) took the Chair, and read Prayers.
- 2. PETITIONS. -- Mr. Cameron presented a petition from certain Greek migrants living in the Commonwealth opposing any proposition to conscript migrant youth for the Armed Services and the Commonwealth Gevernment's decision to conscript youth for service beyond the Commonwealth and its Territories, particularly in Vietnam, and praying that the Commonwealth Government reverse its present policy. Petition received and read.
 - A similar petition was presented by Mr. Uren, and was received.
 - Mr. Allan presented a petition from certain citizens of New South Wales praying that the Australian Gevernment increase by an immense amount its contributions to non-military overseas aid such aid to be financed, if necessary, by increases in taxation, administered by some international organization such as the United Nations and offered to countries without reference to political advantage or purposes, but solely on the basis of need.
 - Petition received.

Mr. Lindsay presented a petition from certain citizens of the Commonwealth praying that the Commonwealth Government repeal the Wards' Employment Ordinance and legislate to provide at least the basic wage for all Aboriginal workers in the Northern Territory.

Petition received.

Mr. Beaton presented a petition from certain electors of the Commonwealth praying that the Government implement Article 25 of the Universal Declaration of Human Rights by providing increased social service and housing benefits for the aged, the invalid, the widowed and their dependants. Petit on received and read.

APPROPRIATION BILL (No. 1) 1966-67-BUDGET DEBATE.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time—And on the amendment moved thereto by Mr. Calwell (Leader of the Opposition), viz.:—That all words after "That" be onnitted with a view to inserting the following words in place thereof:—"the House condemns the Budget because—
 - (1) it fails to recognize the injustices wrought upon wage earners because real wages have fallen as prices have risen faster than wages;
 - (2) it makes inadequate adjustments to social service payments;
 - (3) it fails to recognize the serious crisis in education;
 - (4) it does not acknowledge the lack of confidence on the part of the business community in the future growth of the economy;
 - (5) it does not recognize the need of further basic development, public and private, in addition to the need for adequate defence, and that balanced development can only take place by active encouragement to Australian industry and co-operation with the States; and
 - (6) it does nothing to relieve our dependence on a high rate of foreign investment to finance the deficit in our balance of payments "----

- 7. THREAT OF VIOLENCE TO LEADER OF THE OPPOSITION—MINISTERIAL STATEMENT.—Mr. Snedden (Attorney-General), by leave, made a ministerial statement informing the House that anonymous telephone calls had been received in Melbourne and Adelaide which threatened violence to the Leader of the Opposition. Mr. Snedden stated that action had been taken by the Commonwealth Police Force with the purpose of preventing any harm befalling the Leader of the Opposition.
