## THURSDAY, 22ND SEPTEMBER, 1966.

- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—The Acting Speaker (Mr. Lucock) took the Chair, and read Prayers.
- 2. DISTINGUISHED VISITORS.—Mr. Acting Speaker informed the House that a party of Members of the Legislative Council for the Territory of Nauru was present in the gallery of the House. On behalf of all Members, Mr. Acting Speaker extended to the visitors a warm welcome.
- 3. Petition.—Mr. Harding presented a petition from certain electors of the Commonwealth praying that the Government implement Article 25 of the Universal Declaration of Human Rights by providing increased social service and housing benefits for the aged, the invalid, the widowed and their dependants. Petition received.
- 4. QUESTIONS.—Questions without notice were asked.
- 5. TERTIARY EDUCATION—REPORTS AND STATEMENT—PAPER NOTED.—Mr. Holt (Prime Minister) presented, pursuant to statute, the following paper:—

Australian Universities Commission Act—Australian Universities Commission—Third Report on Australian Universities, 1964–1969.

- Mr. Holt, by command of His Excellency the Governor-General, also presented the following papers:—Advanced Education—Commonwealth Advisory Committee—First Report, June, 1966 (Colleges of Advanced Education, 1967-69).
  - Tertiary Education—Statement presented by the Prime Minister in the House of Representatives, 22nd September, 1966—

and moved, That the House take note of the statement.

- 6. Paper.—The following paper was presented, by command of His Excellency the Governor-General— International Labour Conference—Forty-fourth Session, 1960—Statement in relation to the Convention and Recommendations adopted by the Session.
- 7. Leave of Absence to Member.—Mr. Calwell (Leader of the Opposition) moved, That leave of absence for one month be given to the honorable Member for Dalley (Mr. O'Connor) on the ground of public business overseas.

Ouestion—put and passed.

8. POULTRY INDUSTRY LEVY BILL 1966.—Mr. Adermann (Minister for Primary Industry) presented a Bill for an Act to amend the *Poultry Industry Levy Act* 1965 in relation to Exemption from Levy in respect of Broiler Breeder Hens, and in relation to Decimal Currency.

Bill read a first time.

Mr. Adermann moved, That the Bill be now read a second time.

Debate adjourned (Mr. Pollard), and the resumption of the debate made an order of the day for the next sitting.

 AIR NAVIGATION (CHARGES) BILL 1966.—Mr. Swartz (Minister for Civil Aviation), pursuant to notice, presented a Bill for an Act relating to Charges in respect of Commonwealth Air Navigation Facilities and Services.

Bill read a first time.

Mr. Sv/artz moved, That the Bill be now read a second time.

Debate adjourned (Mr. Whitlam), and the resumption of the debate made an order of the day for the next sitting.

 NATIONAL HEALTH BILL 1966.—Mr. Forbes (Minister for Health), pursuant to notice, presented a Bill for an Act to amend the National Health Act 1953-1965 in relation to Pensioners, Special Account Contributors and Decimal Currency.

Bill read a first time.

Mr. Forbes moved, That the Bill be now read a second time.

Debate adjourned (Mr. Daly), and the resumption of the debate made an order of the day for the next sitting.

11. Senate Elections Bill 1966.—Mr. Anthony (Minister for the Interior), pursuant to notice, presented a Bill for an Act to make provision for the Election of Senators at a General Election of Members of the House of Representatives.

Bill read a first time.

Mr. Anthony moved, That the Bill be now read a second time.

Debate adjourned (Mr. Whitlam), and the resumption of the debate made an order of the day for the next sitting.

12. Loan Bill (No. 2) 1966.—Mr. Howson (Minister assisting the Treasurer), pursuant to notice, presented a Bill for an Act to Authorize the Raising and Expending of a sum not exceeding Three hundred million dollars for Defence Purposes.

Bill read a first time.

Mr. Howson moved, That the Bill be now read a second time.

Debate adjourned (Mr. Webb), and the resumption of the debate made an order of the day for the next sitting.

13. Social Services Bill 1966.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time—

Debate resumed by Mr. Daly who moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof:—"whilst not opposing the provisions of the Bill, the House condemns the Government because—

- (1) the proposed increase in pension rates still leaves the pensioner's standard of living below what is a reasonable Australian minimum;
- (2) the Government is perpetuating the sub-standard rate for married pensioners despite the glaring anomalies and injustices in this course;
- (3) there is still no change in the income means test which has now remained unchanged during twelve years of inflation and rising prices;
- (4) the Government has once again failed to put any value back into the child endowment payments and has repudiated its pledges by allowing many other social services to lose their value, and
- (5) it has failed to make benefits retrospective to the 1st July, 1966".

Debate continued.

Debate adjourned (Mr. Cleaver), and the resumption of the debate made an order of the day for a later hour this day.

- 14, AIRCRAFT ACCIDENT NEAR WINTON, QUEENSLAND—MINISTERIAL STATEMENT.—Mr. Swartz (Minister for Civil Aviation), by leave, made a ministerial statement informing the House that a Viscount airliner VH-RMI, owned and operated by Ansett-A.N.A., while on a passenger flight from Mount Isa to Longreach, had crashed this afternoon in the Winton area of Queensland.
- 15. Social Services Bill 1966.—The order of the day having been read for the resumption of the debate on the question, That the Bill be now read a second time—And on the amendment moved thereto by Mr. Daly, viz.:—That all words after "That" be omitted with a view to inserting the following words in place thereof:—"whilst not opposing the provisions of the Bill, the House condemns the Government because—
  - (1) the proposed increase in pension rates still leaves the pensioner's standard of living below what is a reasonable Australian minimum;
  - (2) the Government is perpetuating the sub-standard rate for married pensioners despite the glaring anomalies and injustices in this course;
  - (3) there is still no change in the income means test which has now remained unchanged during twelve years of inflation and rising prices;
  - (4) the Government has once again failed to put any value back into the child endowment payments and has repudiated its pledges by allowing many other social services to lose their value, and

- 16. AIRCRAFT ACCIDENT NEAR WINTON, QUEENSLAND—MINISTERIAL STATEMENT.—Mr. Swartz (Minister for Civil Aviation), by leave, made a ministerial statement regarding the crash of Ansett-A.N.A. Viscount 800, VH-RMI, which he had reported earlier in the day and informed the House that the death roll comprised 20 passengers and 4 crew. Mr. Swartz expressed sincere sympathy to all relatives of those killed and stated that the fullest investigation would be made into the tragedy. Mr. Whitlam, by leave, associated the Opposition with the expression of sympathy.
- 17. ADJOUNNMENT.—Mr. Fairbairn (Minister for National Development) moved, That the House do now adjourn.
