- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr J. R. Fraser presented a petition from certain residents of Canberra praying that this House will, as a matter of urgency, direct that the appropriate authorities take all necessary action to have pedestrian traffic lights and any other safety devices deemed essential installed at the Limestone Avenue, Donaldson Street and Elder Street intersections.
 - Mr St. John presented a petition from certain citizens of the Commonwealth praying that the Commonwealth Government co-operate with the State Government of New South Wales in sparing the Customs House Building, Circular Quay, from possible demolition and in undertaking its conversion into a National Maritime Museum.

Petitions severally received and read.

Mr Forbes rising to continue his answer-

Suspension of standing orders moved: Mr J. R. Fraser moved—That so much of the standing orders be suspended as would prevent Mr Forbes completing his answer without limitation of time.

Speaker's ruling: Mr Speaker ruled that as time limits were not applicable to questions and answers there was no point in the motion and therefore it was out of order.

Mr Forbes completed his answer.

- 4 ANZAC COMMEMORATIVE MEDALLION AND BADGE—MINISTERIAL STATEMENT AND PAPER:

 Mr Holt (Prime Minister), by leave, made a ministerial statement concerning arrangements for the issue of the Anzac Commemorative Medallion and Badge, and, by command of His Excellency the Governor-General, presented the following paper:

 Anzac Commemorative Medallion and Badge—Statement with respect to conditions of eligibility and applications.
- 5 SPECIAL ADJOURNMENT: Mr Snedden (Leader of the House) moved—That the House, at its rising, adjourn until Tuesday, 4 April, at half-past two o'clock p.m. Question—put and passed.
- 6 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—BUREAU OF MINERAL RESOURCES: Mr Speaker informed the House that Mr Luchetti had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The excessive number of resignations from the professional staff of the Bureau of Mineral Resources in recent years, particularly in the last three months, leading to disruption of the activities of the Bureau and the lowering of its morale".

The proposed discussion having received the necessary support—

Mr Luchetti addressed the House.

Discussion ensued.

Discussion concluded.

- 7 Suspension of standing orders—General business notice: Mr Snedden (Leader of the House) moved, by leave—That so much of the standing orders be suspended as would prevent notice No. 1, general business, being called on forthwith and consideration of the notice being continued until fifteen minutes past three o'clock p.m. Question—put and passed.
- 8 EQUAL PAY FOR EQUAL WORK IN PUBLIC SERVICE: Sir Wilfrid Kent Hughes moved, pursuant to notice—That this House approves of the principle of equal pay for equal work for men and women officers of the Public Service and requests the Government to amend accordingly Regulations 104, 105, and 106 under section 30 of the Public Service Act.

Debate ensued.

- The time allotted for the consideration of the motion having expired, the debate was interrupted, Mr Snedden (Minister for Immigration) was granted leave to continue his speech when the debate is resumed, and the resumption of the debate was made an order of the day for the next sitting.
- 9 DIPLOMATIC PRIVILEGES AND IMMUNITIES, CUSTOMS TARIFF (No. 2), EXCISE TARIFF, INCOME TAX ASSESSMENT, PAY-ROLL TAX ASSESSMENT, AND SALES TAX (EXEMPTIONS AND CLASSIFICATIONS) BILLS 1967: The order of the day having been read for the resumption of the debate on the question—That the Bills be now read a second time—Debate resumed.

Question—put and passed—Bills together read a second time.

The House resolved itself into a committee of the whole.

In the committee

Diplomatic Privileges and Immunities Bill 1967— Clauses 1 to 7, by leave, taken together, and agreed to, after debate. Remainder of Bill, by leave, taken as a whole, and agreed to, after debate. Remaining five Bills, by leave, taken as a whole together, and agreed to. Bills to be reported without amendment. The House resumed; Mr Failes reported accordingly.

On the motion of Mr Hasluck (Minister for External Affairs), the House adopted the report, and the Bills were together read a third time.

10 Customs Tariff Proposals No. 6 (1967): Mr Howson (Minister representing the Minister for Customs and Excise) moved Customs Tariff Proposals No. 6 (1967).

Debate adjourned (Mr Barnard), and the resumption of the debate made an order of the day for the next sitting.

11 Papers: The following papers were presented, by command of His Excellency the Governor-General:

Cycle saddles.

Electrical capacitors.

Plastic corrugated plates, sheets or strip.

Severally ordered to be printed.

12 Excise Tariff Proposals No. 1 (1967): Mr Howson (Minister representing the Minister for Customs and Excise) moved Excise Tariff Proposals No. 1 (1967).

Debate adjourned (Mr J. F. Cairns), and the resumption of the debate made an order of the day for the next sitting.

- 13 POSTPONEMENT OF ORDER OF THE DAY: Ordered—That order of the day No. 2, government business, be postponed until a later hour this day.
- 14 TASMANIA GRANT (GORDON RIVER ROAD) BILL 1967: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Message from the Governor-General: Mr Speaker announced the receipt of message No. 4, dated 22 February 1967, from His Excellency the Governor-General recommending an appropriation of revenue for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Howson (Minister assisting the Treasurer), the Bill was read a third time.

15 Customs Tariff Bill 1967: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr J. F. Cairns who moved, as an amendment—That all words after "That" be omitted with a view to inserting the following words in place thereof: "while not declining to give the Bill a second reading this House is of the opinion that the Tariff Board needs to develop more effective means of ascertaining what are or may become economic and efficient ventures for which it recommends protection or assistance, and that the Government should take steps to ensure that the companies to which protection is given follow price, production, export and dividend policies which are in the interests of economic and efficient development, as well as of full employment and a stable and rapid rate of investment".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time

Leave granted for third reading to be moved forthwith.

On the motion of Mr Howson (Minister representing the Minister for Customs and Excise), the Bill was read a third time.

16 JOINT COMMITTEE ON THE BROADCASTING OF PARLIAMENTARY PROCEEDINGS: Mr Snedden (Leader of the House) moved, by leave—That, in accordance with the provisions of the Parliamentary Proceedings Broadcasting Act 1946-1960, in addition to Mr Speaker, ex officio, Mr Arthur, Miss Brownbill, Mr Costa, Mr Luchetti and Mr Turnbull be members of the Joint Committee on the Broadcasting of Parliamentary Proceedings. Question—put and passed.

17 ADJOURNMENT: Mr Snedden (Leader of the House) moved—That the House do now adjourn.

Debate ensued.

Question-put and passed.

And then the House, at twelve minutes to twelve o'clock midnight, adjourned until Tuesday, 4 April, at half-past two o'clock p.m.
