THURSDAY, 4 MAY 1967

- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. The Acting Speaker (Mr Lucock) took the Chair, and read Prayers.
- 2 MINISTERIAL ARRANGEMENTS: Mr Holt (Prime Minister) informed the House that, during the absence abroad of Mr Anthony (Minister for the Interior), Mr Kelly (Minister for Works) would act as Minister for the Interior.
- 3 QUESTIONS: Questions without notice were asked.
- 4 EUROPEAN ECONOMIC COMMUNITY—PROPOSED ENTRY OF BRITAIN—MINISTERIAL STATE-MENT: Mr Holt (Prime Minister), by leave, made a ministerial statement with reference to the proposed application by Britain to join the European Economic Community. Mr J. F. Cairns, by leave, also made a statement with reference to the matter.
- 5 FIVE DOLLAR NOTE—MINISTERIAL STATEMENT—PAPER NOTED: Mr McMahon (Treasurer), by leave, made a ministerial statement with reference to the issue of the new five dollar note, and, by command of His Excellency the Administrator of the Government of the Commonwealth, presented the following paper:

and moved—That the House take note of the paper.

Debate ensued.

Question-put and passed.

6 WITHHOLDING TAX—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER: Mr McMahon (Treasurer), by leave, made a ministerial statement informing the House that the Government had decided to introduce a withholding tax on interest paid to persons, including companies, who are not residents of Australia, and, by command of His Excellency the Administrator of the Government of the Commonwealth, presented the following paper:

Withholding Tax—Ministerial statement, 4 May 1967—

and moved—That the House take note of the paper.

- Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.
- 7 SUSPENSION OF STANDING ORDERS-GENERAL BUSINESS NOTICE: Mr Snedden (Leader of the House) moved, by leave—That so much of the standing orders be suspended as would prevent the consideration of notice No. 1, general business, being continued until three o'clock p.m.

Question-put and passed.

8 NATIONAL WATER CONSERVATION AND CONSTRUCTING AUTHORITY: Mr Patterson moved, pursuant to notice—That a National Water Conservation and Constructing Authority, embracing the Snowy Mountains Hydro-electric Authority, be established by the Commonwealth to carry out, in association with State Governments, the systematic development of soundly based water storage projects in the major river systems serving those established and proven areas which are periodically devastated by recurring droughts. Debate ensued.

- The time allotted for the consideration of the motion having expired, the debate was interrupted, Mr Barnes (Minister for Territories) was granted leave to continue his speech when the debate is resumed, and the resumption of the debate was made an order of the day for the next sitting.
- 9 WOOL INDUSTRY BILL 1967: Mr Adermann (Minister for Primary Industry), pursuant to notice, presented a Bill for an Act to amend the Wool Industry Act 1962-1966. Bill read a first time.

Mr Adermann moved—That the Bill be now read a second time.

Debate adjourned (Mr Beaton), and the resumption of the debate made an order of the day for the next sitting.

10 BROADCASTING AND TELEVISION BILL 1967: Mr Hulme (Postmaster-General), pursuant to notice, presented a Bill for an Act to amend the Broadcasting and Television Act 1942-1966.

Bill read a first time.

Mr Hulme moved—That the Bill be now read a second time.

Debate adjourned (Mr Beaton), and the resumption of the debate made an order of the day for the next sitting.

- 11 POSTPONEMENT OF NOTICE: Mr Sinclair (Minister for Social Services) moved-That notice No. 3, government business, be postponed until a later hour this day. Debate ensued. Question-put and passed.
- 12 AGED PERSONS HOMES BILL 1967-SENATE'S AMENDMENT: The House, according to order, resolved itself into a committee of the whole to consider the amendment made by the Senate.

Mr Sinclair, on behalf of the committee, brought up such reasons, which were read, and are as follows:

Reasons of the House of Representatives for disagreeing to the amendment of the Senate

Because:

A trade union is in no different position to any other organisation that does not fall within paragraph (a) of the definition of eligible organisation. There is no more reason why a trade union should be selected for specific mention in a separate paragraph than there is for other organisations such as the Country Women's Association, Rotary Clubs, Lions Clubs, Apex Clubs or associations of employers. It would be open to any of these organisations including a trade union to establish a trust for charitable or benevolent purposes such as the conduct of an aged persons home, and have that trust approved by the Governor-General for the purposes of the Act. The trustee or trustees of the trust would then be an eligible organisation under paragraph (e) of the definition.

Alternatively a trade union could be approved by the Governor-General under sub-paragraph (iv) of paragraph (a) if it was not carried on for the purpose of profit or gain to its individual members.

Mr Sinclair moved—That the committee's reasons be adopted.

Debate ensued.

Question-put and passed.

- 14 FOREIGN AFFAIRS—PROPOSED JOINT COMMITTEE: Mr Hasluck (Minister for External Affairs) moved, by leave—
 - (1) That a joint committee be appointed to consider foreign affairs generally and to report to the Minister for External Affairs upon such matters as are referred to it by the Minister.
 - (2) That the committee consist of eight Members of the House of Representatives appointed by the Prime Minister, five Members of the House of Representatives appointed by the Leader of the Opposition in the House of Representatives, four Senators appointed by the Leader of the Government in the Senate and three Senators appointed by the Leader of the Opposition in the Senate.
 - (3) That every appointment of a member of the committee be forthwith notified in writing to the President of the Senate and the Speaker of the House of Representatives.
 - (4) That the Minister for External Affairs shall make available to the committee information within such categories or on such conditions as he may consider desirable.
 - (5) That the members of the committee shall hold office as a joint committee until the House of Representatives expires by dissolution or effluxion of time.
 - (6) That the committee shall have power to appoint sub-committees consisting of four or more of its members; and to refer to any such sub-committees any of the matters which the committee is empowered to consider.
 - (7) That the committee or any sub-committee shall have power to adjourn from place to place and to sit during any recess or adjournment of the Parliament and during the sittings of either House of the Parliament.
 - (8) That the committee and its sub-committees shall sit *in camera* and their proceedings shall be secret unless the Minister at the request of the committee otherwise directs.
 - (9) That seven members of the committee constitute a quorum of the committee and three members of a sub-committee shall consitute a quorum of that sub-committee.
 - (10) That (a) on every occasion when the committee reports to the Minister on any matter pursuant to his request the committee shall inform the Parliament of the fact that it has so reported, otherwise the proceedings of the committee shall not be reported to either House;
 - (b) the Minister shall forward a copy of any such report as he has requested to the Leader of the Opposition for his confidential information;
 - (c) the committee may communicate with the Minister but all communications with the Minister and the fact of any such communication shall be confidential to the committee and the Minister.
 - (11) That the committee shall have power to invite persons to give evidence before the committee.
 - (12) That with the consent of the Minister for External Affairs, the committee shall have power to call for official papers or records.
 - (13) That all written and oral evidence submitted to or received by the committee *in camera* shall be confidential to the committee and the Minister.

- (14) That any member of the committee have power to add a protest or dissent to any report, but the protest or dissent may not introduce new matter not referred to in the main report.
- (15) That the committee have power to consider the minutes of evidence and records of the Joint Committee on Foreign Affairs appointed in the previous Parliament relating to any matter on which that committee had not completed its consideration.
- (16) That the foregoing provisions of this resolution, so far as they are inconsistent with the standing orders, have effect notwithstanding anything contained in the standing orders.
- (17) That a message be sent to the Senate acquainting it of this resolution and requesting that it concur and take action accordingly.
