#### WEDNESDAY, 27 SEPTEMBER 1967

- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 QUESTIONS: Questions without notice were asked.
- 3 PAPERS: The following papers were presented, by command of His Excellency the Governor-General:

Australian Egg Board—Interim Annual Report, for year 1966-67.

Snowy Mountains Hydro-electric Authority—Interim Annual Report, for year 1966-67.

The following papers were presented, pursuant to statute:

Atomic Energy Act—Australian Atomic Energy Commission—Fifteenth Annual Report and financial statements, together with the Auditor-General's Report, for year 1966–67.

Poultry Industry Assistance Act-Second Annual Report, for year 1966-67.

4 MESSAGE FROM THE GOVERNOR-GENERAL—ASSENT TO BILLS: A Message from His Excellency the Governor-General was announced informing the House that His Excellency, in the name of Her Majesty, had assented to the following Bills:

26 September 1967—Message No. 51— Post and Telegraph Rates 1967.

Post and Telegraph Regulations 1967.

- 5 NEW AND PERMANENT PARLIAMENT HOUSE—PROPOSED JOINT SELECT COMMITTEE: Mr Holt (Prime Minister) moved, pursuant to notice—
  - (1) That, having in mind proposals for the erection of a new and permanent Parliament House (in this resolution referred to as "the Parliament building") and in that connection the need to examine the efficiency or otherwise of working arrangements in the present Parliament House and any changes in those arrangements that may seem to be desirable, a Joint Select Committee be appointed to inquire into and report on—
    - (a) the accommodation needs of—
      - (i) the Senate, the House of Representatives and the Parliamentary staff in the Parliament building;
      - (ii) members of the public visiting the Parliament building; and
      - (iii) library facilities, and catering and other facilities and services in the Parliament building for Members of the Parliament and others;
    - (b) whether, and, if so, to what extent or in what manner, the following should be accommodated in the Parliament building—
      - (i) the Executive;
      - (ii) the press; and
      - (iii) communication services; and
    - (c) matters incidental to the foregoing matters.

(2) That the committee consist of—

- (a) the President of the Senate, who shall be Chairman;
- (b) the Speaker of the House of Representatives, who shall be Deputy Chairman;
- (c) the Prime Minister;
- (d) the Leader of the Country Party in the House of Representatives;
- (e) the Leader of the Opposition in the House of Representatives;
- (f) a member of the Opposition in the Senate or the House of Representatives appointed jointly by the Leader of the Opposition in the Senate and the Leader of the Opposition in the House of Representatives;
- (g) eight Members of the House of Representatives, four of whom shall be appointed by the Prime Minister and four by the Leader of the Opposition in that House; and
- (h) four Senators, two of whom shall be appointed by the Leader of the Government in the Senate and two by the Leader of the Opposition in the Senate.
- (3) That the member of the committee referred to in paragraph (c), (d), (e) or (f) of paragraph (2) of this resolution have power to appoint a Member of the House of Representatives or a Senator to attend the committee when the member of the committee is not present at a meeting of the committee.
- (4) That a person so appointed, when attending a meeting of the committee, be deemed to be a member of the committee.
- (5) That every appointment of a member of the committee, and every appointment under paragraph (3) of this resolution, be forthwith notified in writing to the President of the Senate and the Speaker of the House of Representatives.
- (6) That the members of the committee hold office as a joint committee until the House of Representatives expires by dissolution or effluxion of time.
- (7) That the committee have power to appoint sub-committees consisting of six or more of its members and to refer to such a sub-committee any matter that the committee is empowered to inquire into.
- (8) That the committee, or a sub-committee so appointed, have power to send for persons, papers and records and to sit during any adjournment or recess of the Parliament and during the sitting of either House of the Parliament.
- (9) That the committee have power to consider and make use of the minutes of evidence and records of the Joint Select Committee on the New and Permanent Parliament House appointed during the Twenty-fifth Parliament.
- (10) That the committee have leave to report from time to time and that any member of the committee have power to add a protest or dissent to any report.
- (11) That ten members of the committee, including the Chairman or Deputy Chairman, constitute a quorum of the committee and four members of a sub-committee constitute a quorum of the sub-committee.
- (12) That, in matters of procedure, the Chairman or Deputy Chairman presiding at a meeting have a deliberative vote and, in the event of any equality of votes, have a casting vote and that, in other matters, the Chairman or Deputy Chairman have a deliberative vote only.
- (13) That the foregoing provisions of this resolution, in so far as they are inconsistent with the standing orders, have effect notwithstanding anything contained in the standing orders.
- (14) That a message be sent to the Senate acquainting it with this resolution and requesting the Senate that it concur and take action accordingly.Question—put and passed.
- 6 PRECEDENCE TO GOVERNMENT BUSINESS: Mr Snedden (Leader of the House) moved, pursuant to notice—That government business shall take precedence over general business tomorrow.

Question-put and passed.

7 REPATRIATION BILL 1967: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

- Debate resumed by Mr Barnard (Deputy Leader of the Opposition) who moved, as an amendment—That all words after "That" be omitted with a view to inserting the following words in place thereof: "whilst not declining to give the Bill a second reading, this House is of the opinion that the rates of pension for totally and permanently incapacitated ex-servicemen, the general rate pensioner and war widows are inadequate and should be revised".
- Speaker's ruling: Mr Speaker ruled that the amendment was out of order as it was not relevant to the Bill.

*Dissent from ruling*: Mr Barnard moved—That the ruling be dissented from. Debate ensued on the motion of dissent.

8 SALES TAX (EXEMPTIONS AND CLASSIFICATIONS) BILL (No. 3) 1967: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

On the motion of Mr Howson (Minister assisting the Treasurer), the House adopted the report, and, by leave, the Bill was read a third time.

9 COMMONWEALTH EMPLOYEES' COMPENSATION BILL 1967: Mr Howson (Minister assisting the Treasurer), by leave, presented a Bill for an Act to increase certain amounts of Compensation payable to Employees of the Commonwealth and to amend the *Commonwealth Employees' Compensation Act* 1930–1964 in relation to Decimal Currency.

Bill read a first time.

Mr Howson moved—That the Bill be now read a second time.

Debate adjourned (Mr Webb), and the resumption of the debate made an order of the day for the next sitting.

10 APPROPRIATION BILL (No. 1) 1967-68: The House, according to order, resolved itself into a committee of the whole for the further consideration of the Bill.
