- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 DEATH OF SENATOR D. C. HANNAFORD: Mr Holt (Prime Minister) referred to the death of Senator D. C. Hannaford, and moved—That this House expresses its deep regret at the death on 24 October 1967 of Douglas Clive Hannaford, a Senator for the State of South Australia, places on record its appreciation of his long and meritorious public service and tenders its profound sympathy to his widow and family in their bereavement.
 - And Mr Whitlam (Leader of the Opposition) having seconded the motion, and Mr Anthony (Minister for Primary Industry), Mr Forbes (Minister for Health), Mr J. R. Fraser and Mr Wentworth having addressed the House in support thereof, and all Members present having risen, in silence—

Question-passed.

3 Petitions: Mr Whitlam (Leader of the Opposition) presented a petition from certain citizens of Australia praying that the Australian Government set one per cent of the gross national product as a target for the annual allocation of aid to the developing countries.

Petition received and read.

Mr Clark presented a petition from certain electors of the Commonwealth praying that the well-being of the aged, the infirm, the widowed, the deserted wives and dependent children, and the service pensioner be improved to parity with the national general living standard of the Australian people.

Petition received.

7 ROCKHAMPTON AIRPORT, QLD—DEVELOPMENT OF AIRFIELD PAVEMENTS—APPROVAL OF WORK: Mr Kelly (Minister for Works) moved, pursuant to notice—That, in accordance with the provisions of the Public Works Committee Act 1913-1966, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the committee has duly reported to this House: Rockhampton Airport, Qld—Development of airfield pavements.

"7. Section 7 of the Principal Act is amended-

Grant of furlough to temporary

- (a) by omitting from sub-section (1.) the word 'may' and inserting in its stead the word 'shall';
- (b) by omitting from sub-section (2.) the word 'may' and inserting in its stead the word 'shall'; and
- (c) by omitting from sub-section (2.) the words 'the salary for a period of leave not exceeding that which the employee could have been granted under sub-section (1.) of this section' and inserting in their stead the words 'his salary for a period not exceeding the period, or the sum of the periods, of leave on full salary that could have been granted to the employee under sub-section (1.) of this section if he had not ceased to be an employee'."

Debate continued.

Question—That the clause proposed to be omitted stand part of the Bill—put.
