- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
 - 2 QUESTIONS: Questions without notice were asked.
 - 3 PAPERS: The following papers were presented, by command of His Excellency the Governor-General:
 - National Radiation Advisory Committee—Report, dated December 1967, on the biological aspects of fallout in Australia from French nuclear weapons explosions in the Pacific, June–July 1967.
 - New South Wales Intrastate Air Services—Report of Committee of Enquiry, dated 1 April 1968.
 The following paper was presented, pursuant to statute:
 - Dairy Produce Export Control Act—Australian Dairy Produce Board—Forty-second Annual Report, for year 1966–67.
 - 4 HELICOPTER ACCIDENT AT BARRACOUTA OFF-SHORE OIL RIG, NEAR SALE, VICTORIA—MINISTERIAL STATEMENT: Mr Swartz (Minister for Civil Aviation), by leave, made a ministerial statement informing the House of the progress made in connection with investigations into the accident to Bell 204B Helicopter VH-UTW on 22 March at Barracouta off-shore oil rig, near Sale, Victoria.
