TUESDAY, 4 JUNE 1968

- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr Bury (Minister for Labour and National Service) presented a petition from certain citizens of the Commonwealth praying that this House take the necessary steps to repeal those amendments to the National Service legislation which undermine the rights of individuals and of educational and other institutions.

Petition received.

- Petitions from certain electors of the Commonwealth praying that the Government implement Article 25 of the Universal Declaration of Human Rights by providing increased social service and housing benefits for the aged, the invalid, the widowed and their dependants were presented by Mr Clark, Mr Luchetti and Mr Connor. Petitions severally received.
- 3 MINISTERIAL ARRANGEMENTS: Mr Gorton (Prime Minister) informed the House that, during the absence abroad of Mr Swartz (Minister for Civil Aviation), Senator Scott (Minister for Customs and Excise) would act as Minister for Civil Aviation and Mr Fairbairn (Minister for National Development) would handle Civil Aviation matters in this House.
- 4 QUESTIONS: Questions without notice were asked.
- 5 AUSTRALIAN COUNCIL FOR THE ARTS—MINISTERIAL STATEMENT: Mr Gorton (Prime Minister), by leave, made a ministerial statement informing the House of the persons whom he had invited, and who had accepted the invitation, to become members of the Australian Council for the Arts.
- 6 International Labour Conference—Forty-seventh Session, 1963—Statement—Motion to take note of paper: Mr Bury (Minister for Labour and National Service), by command of His Excellency the Governor-General, presented the following paper: International Labour Conference—Forty-seventh Session, 1963—Statement in relation to the Convention and Recommendations adopted at the Session—and moved—That the House take note of the paper.
