# HOUSE OF REPRESENTATIVES VOTES AND PROCEEDINGS

#### WEDNESDAY, 5 JUNE 1968

- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr Uren presented a petition from certain electors of the Commonwealth praying that the Government implement Article 25 of the Universal Declaration of Human Rights by providing increased social service and housing benefits for the aged, the invalid, the widowed and their dependants.

Petition received and read.

A similar petition was presented by Mr Beaton, and was received.

- 3 MINISTERIAL ARRANGEMENTS: Mr Gorton (Prime Minister) informed the House that, during the forthcoming respective absences abroad of himself, Mr Fairhall (Minister for Defence) and Mr Hasluck (Minister for External Affairs), Mr McEwen (Minister for Trade and Industry) would act as Prime Minister, Mr Hulme (Postmaster-General) would act as Minister for Defence, and Mr Freeth (Minister for Air) would act as Minister for External Affairs. Mr Gorton also informed the House that, during the absence abroad this week of Mr Barnes (Minister for External Territories), Mr Kelly (Minister for the Navy) would deal with External Territories matters in this House.
- 4 QUESTIONS: Questions without notice were asked.
- 5 Paper: The following paper was presented, pursuant to statute: Wheat Research Act—Tenth Annual Report, for 1967.
- 6 Suspension of standing orders—Motion of lack of confidence in Minister for the Army: Mr Snedden (Leader of the House) moved, by leave—That so much of the standing orders be suspended as would prevent Mr Barnard (Deputy Leader of the Opposition) moving forthwith the motion of lack of confidence in the Minister for the Army (Mr Lynch) of which he has given notice for the next sitting, and that such motion take precedence of all other business until disposed of.

7 MINISTER FOR THE ARMY—MOTION OF LACK OF CONFIDENCE: Mr Barnard (Deputy Leader of the Opposition) moved—That the Minister for the Army lacks the confidence of the House because of the maladministration and misinformation for which he is responsible.

8 Message from the Senate—Death Penalty Abolition Bill 1968: Mr Speaker reported message No. 40, dated 4 June 1968, from the Senate transmitting for the concurrence of the House a Bill for "An Act to abolish Capital Punishment under the Laws of the Commonwealth".

Opposition Members calling for a division—

There could be no division and the resumption of the debate would accordingly be put down in the name of Mr Bowen who moved the adjournment of the debate.
