- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 Petition: Mr Everingham presented a petition from certain electors of the Commonwealth praying that this House (1) take any action necessary to ensure that the Government does not implement the Resolution of the Security Council of the United Nations imposing economic sanctions upon the Government and people of Rhodesia and (2) will consider the advisability of sending a fact finding mission to Rhodesia to see and hear at first hand the conditions of life of black Africans in Rhodesia and the present and future policy of the Rhodesian Government concerning black Africans.

Petition received and read.

- 3 QUESTIONS: Questions without notice were asked.
- 4 Papers—Ministerial statement: The following papers were presented, pursuant to statute:
 - Air Navigation Act—Minister for Civil Aviation—Eighth Annual Report, for year 1967-68.
 - Broadcasting and Television Act—Australian Broadcasting Control Board— Twentieth Annual Report and financial statement, together with the Auditor-General's Report, for year 1967-68.
 - Defence Act—Royal Military College of Australia—Report for period 11 February 1967 to 26 January 1968.
 - War Service Homes Act—Director of War Service Homes—Report and financial statements, for year 1967-68.
 - Mr Lynch (Minister for the Army), by leave, made a ministerial statement in connection with the report on the Royal Military College of Australia.
- 5 LOAN RAISING IN GERMANY—MINISTERIAL STATEMENT: Mr Gorton (Acting Treasurer), by leave, made a ministerial statement informing the House of successful negotiations in Germany for a loan of \$44.6 million.
- 6 FISHERIES NEGOTIATIONS WITH JAPAN—MINISTERIAL STATEMENT: Mr Hasluck (Minister for External Affairs), by leave, made a ministerial statement informing the House that the Government would give early consideration to a draft agreement with Japan concerning Japanese tuna long-line fishing in waters off Australia and certain of the Territories.
- 7 SEAMEN'S COMPENSATION BILL 1968: Mr Sinclair (Minister for Shipping and Transport), pursuant to notice, presented a Bill for an Act to increase the Amounts of Weekly Payments of Compensation payable to, and in respect of, Seamen.

Bill read a first time.

Mr Sinclair moved—That the Bill be now read a second time.

8 NORTHERN TERRITORY SUPREME COURT BILL 1968: Mr Bowen (Attorney-General), pursuant to notice, presented a Bill for an Act to amend the *Northern Territory Supreme Court Act* 1961–1966 in respect of the jurisdiction of the Supreme Court of the Northern Territory of Australia.

Bill read a first time.

Mr Bowen moved—That the Bill be now read a second time.

Debate adjourned (Mr Patterson), and the resumption of the debate made an order of the day for the next sitting.

9 ELECTORAL DIVISIONS OF NEW SOUTH WALES—PROPOSED REDISTRIBUTION: Mr Nixon (Minister for the Interior) moved, pursuant to notice—That the House of Representatives approves of the redistribution of the State of New South Wales into Electoral Divisions as proposed by Messrs F. L. Ley, C. W. Prince and R. F. Mallon, the Commissioners appointed for the purpose of redistributing the said State into Divisions, in their Report laid before the House of Representatives on the 18th day of September, 1968, and that the names of the Divisions suggested in the Report, and indicated in the map referred to therein, be adopted, except that the name "Ku-ringgai" be substituted for "Hornsby" and the name "Grose" be substituted for "Blacktown" and the name "Cook" be substituted for "Kurnell".

Debate adjourned (Mr Daly), and the resumption of the debate made an order of the day for the next sitting.

10 ELECTORAL DIVISIONS OF VICTORIA—PROPOSED REDISTRIBUTION: Mr Nixon (Minister for the Interior) moved, pursuant to notice—That the House of Representatives approves of the redistribution of the State of Victoria into Electoral Divisions as proposed by Messrs C. J. A. Lack, C. E. Middleton and R. Dowell, the Commissioners appointed for the purpose of redistributing the said State into Divisions, in their Report laid before the House of Representatives on the 18th day of September, 1968, and that the names of the Divisions suggested in the Report, and indicated in the map referred to therein, be adopted, except that the name "La Trobe" be substituted for "Maroondah" and the name "Casey" be substituted for "La Trobe" and the name "Bruce" be substituted for "Waverley" and the name "Holt" be substituted for "Bruce" and the name "Isaacs" be substituted for "Beaumaris".

Debate adjourned (Mr Daly), and the resumption of the debate made an order of the day for the next sitting.

11 ELECTORAL DIVISIONS OF QUEENSLAND—PROPOSED REDISTRIBUTION: Mr Nixon (Minister for the Interior) moved, pursuant to notice—That the House of Representatives approves of the redistribution of the State of Queensland into Electoral Divisions as proposed by Messrs I. Smith, the Commissioners appointed for the purpose of redistributing the said State into Divisions, in their Report laid before the House of Representatives on the 18th day of September, 1968, and that the names of the Divisions suggested in the Report, and indicated in the map referred to therein, be adopted.

Debate adjourned (Mr Whitlam—Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.

Kopp, the Commissioners appointed for the purpose of redistributing the said State into Divisions, in their Report laid before the House of Representatives on the 18th day

of September, 1968, and that the names of the Divisions suggested in the Report, and indicated in the map referred to therein, be adopted, except that the name "Hawker" be substituted for "Holder".
