Sir John Cramer presented a petition from certain citizens of Australia praying that this House take action to restore some of the tribal lands to the Aborigines so that their culture may be appreciated and the process of assimilation gradually achieved. Petition received and read.

Petitions from certain residents of Australia praying that the Government use its influence to achieve the release of all political prisoners, the holding of free elections and the restoration of all other constitutional and democratic rights in Greece and that the Government take steps to prevent further intimidation of Greek migrants in Australia by representatives of the Greek military dictatorship were presented by Mr Webb, Mr C. R. Cameron, Mr Crean and Mr Cross.

Dowell, the Commissioners appointed for the purpose of redistributing the said State into Divisions, in their Report laid before the House of Representatives on the 18th day of September, 1968, but does so with reluctance since the distribution:

- (1) permits a greater inequality of population in the proposed Divisions than has occurred in any previous distribution;
- (2) fails to provide that as nearly as is practicable one man's vote is to be worth as much as another's; and
- (3) ignores the Constitution's plain objective of making equal representation for equal numbers of people the fundamental goal for the House of Representatives, and agrees".
