- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr J. F. Cairns presented a petition from Lillian Verna Louisa Pedlar, an elector of the Commonwealth, praying that the Government urge all in high places, including the delegates at the United Nations, to demand genuine impartial outlawing of war and thus restore stability before there is an unprecedented worsening beyond recall.

Petition received and read.

Mr Hansen presented a petition from certain electors of the Division of Wide Bay praying that the Government convey as urgently as possible its belief to our American allies that all aspects of the war in Vietnam should be intensified, while pursuing a policy of no compromise at the current Paris talks.

Petition received.

Mr Everingham presented a petition from certain citizens of the Commonwealth praying that this House take any action necessary to assist a campaign for a lasting peaceful settlement in Vietnam.

Petition received and read.

A similar petition was presented by Mr Hansen, and was received.

Mr Kelly presented plans in connection with the proposed work.

11 MEAT RESEARCH BILL 1968: Mr Anthony (Minister for Primary Industry), by leave, presented a Bill for an Act to amend the *Meat Research Act* 1960-1965.

Bill read a first time.

Mr Anthony moved—That the Bill be now read a second time.

Debate adjourned (Mr Patterson), and the resumption of the debate made an order of the day for the next sitting.

12 MEAT LEGISLATION REPEAL BILL 1968: Mr Anthony (Minister for Primary Industry), by leave, presented a Bill for an Act to repeal certain Legislation relating to Meat, and for purposes connected therewith.

Bill read a first time.

Mr Anthony moved—That the Bill be now read a second time.

Debate adjourned (Mr Patterson), and the resumption of the debate made an order of the day for the next sitting.

13 Wine Grapes Charges Bill 1968: Mr Anthony (Minister for Primary Industry) presented a Bill for an Act to amend section 3 of the *Wine Grapes Charges Act* 1929-1966. Bill read a first time.

Mr Anthony moved—That the Bill be now read a second time.

Debate adjourned (Mr Patterson), and the resumption of the debate made an order of the day for the next sitting.

14 COMMONWEALTH BANKS BILL 1968: Mr Freeth (Minister assisting the Treasurer), by leave, presented a Bill for an Act to amend the Commonwealth Banks Act 1959–1966 in relation to the Conditions of Service of the Holders of certain Statutory Offices and in relation to the Commonwealth Banking Corporation Service and to repeal section 54 of that Act.

Bill read a first time.

Mr Freeth moved—That the Bill be now read a second time.

Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.

15 GOLD-MINING INDUSTRY ASSISTANCE BILL 1968: Mr Freeth (Minister assisting the Treasurer), by leave, presented a Bill for an Act to amend the Gold-Mining Industry Assistance Act 1954-1966.

Bill read a first time.

Mr Freeth moved—That the Bill be now read a second time.

Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.
