- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 **PETITION:** Mr Scholes presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) Aboriginal ownership of existing reserves throughout the Commonwealth, (2) the recognition of Aboriginal ownership of traditional land at present owned and leased by the Crown and (3) the development of mining, pastoral and other enterprises on all Aboriginal land to be subject to the consent of Aboriginal owners and such conditions as their own legal advisers may arrange.
Petition received and read.
- 3 **QUESTIONS:** Questions without notice were asked.

- 7 **SUSPENSION OF STANDING ORDERS—PRECEDENCE TO GOVERNMENT BUSINESS:** Mr Snedden (Leader of the House) moved, by leave—That so much of the standing orders be suspended as would prevent government business taking precedence over general business at this sitting.
Question—put and passed.
- 8 **POSTPONEMENT OF NOTICES:** Ordered—That notices Nos. 1 to 4, government business, be postponed until a later hour this day.
- 9 **PARLIAMENTARY RETIRING ALLOWANCES BILL 1968:** Mr McMahon (Treasurer), by leave, presented a Bill for an Act relating to Parliamentary Retiring Allowances.
Bill read a first time.
Mr McMahon moved, by leave—That the Bill be now read a second time.
Debate adjourned (Mr Whitlam—Leader of the Opposition), and, by leave, the resumption of the debate made an order of the day for a later hour this day.

- 13 **SUPERANNUATION SCHEME—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER:** Mr McMahon (Treasurer), by leave, made a ministerial statement informing the House of the relief to be provided for officers faced with hardship in taking up additional pension entitlements in the later stages of their public service careers, and, by command of His Excellency the Governor-General, presented the following paper:

and moved—That the House take note of the paper.
Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.
- 14 **GOVERNMENT PUBLISHING POLICY—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER:** Mr McMahon (Treasurer), by leave, made a ministerial statement on Government publishing policy, the establishment and functions of an Australian Government Publishing Service and possible changes in the functions of the Printing Committees

of both Houses. Mr McMahon also made reference to the retirement of the Government Printer, Mr A. J. Arthur, O.B.E., and, by command of His Excellency the Governor-General, presented the following paper:

Bill read a first time.
Mr Whitlam moved—That the Bill be now read a second time.
Debate, by leave, ensued.
At five minutes to four o'clock p.m., the time allotted for the consideration of general business having expired, the debate was interrupted, Mr Peacock was granted leave to continue his speech when the debate is resumed, and the resumption of the debate was made an order of the day for the next sitting.

 Bill read a first time.
 Mr Bowen moved—That the Bill be now read a second time.
 Debate adjourned (Mr Connor), and the resumption of the debate made an order of the day for the next sitting.

30 MESSAGE FROM THE SENATE—STATES GRANTS (SECONDARY SCHOOLS LIBRARIES) BILL 1968: Mr Speaker reported the receipt of the following message from the Senate:

SCHEDULE OF THE AMENDMENT MADE BY THE SENATE

After clause 4 insert the following new clause:—

"4A. The Minister shall cause a statement to be laid before each House of the Parliament as soon as practicable after the end of each year during the period to which this Act applies describing the arrangements in accordance with which payments under this Act have been authorized in that year and stating, in respect of each State—

Annual
statement by
Minister.

(a) in relation to secondary schools not being secondary schools conducted by the State—

- (i) the total amount paid to the State under this Act in that year; and
- (ii) the names of the secondary schools in respect of which approvals for the application of moneys included in that amount have been given, and the amount approved for expenditure in respect of each such school; and

(b) in relation to secondary schools conducted by the State—

- (i) the total amount paid to the State under this Act in that year; and
- (ii) the names of the secondary schools in respect of which the State has, during that year, applied amounts paid to the State under this Act."

On the motion of Mr J. M. Fraser (Minister for Education and Science), the amendment was agreed to, after debate.

SCHEDULE OF REQUESTS BY THE SENATE FOR AMENDMENTS

"8A. There is payable to the leader in the Senate of the second non-Government recognised political party in the Senate an allowance at the rate of One thousand dollars a year, and a further allowance, in respect of the expenses of discharging the duties of his office, at the rate of Five hundred dollars a year."
