TUESDAY, 20 MAY 1969

- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable W. J. Aston) took the Chair, and read Prayers.
- 2 PETITIONS: Mr Fox presented a petition from certain residents of Victoria praying that the Government legislate to stop the indiscriminate shooting of kangaroos and to ban the export of kangaroo skins, mounted heads and meat. Petition received.
 - Mr Arthur presented a petition from certain electors of the Commonwealth praying that adequate refund for physiotherapy treatment ordered by a registered medical practitioner may be included within the Commonwealth benefits scheme in like manner to other medical benefits.

Petition received and read.

- Mr Jess presented a petition from certain residents of Victoria praying that the export of kangaroo products be banned immediately and, until such time as a Commonwealth body is set up with appropriate powers, short-term measures be taken to ensure the survival of the kangaroo.
- Mr Bosman presented a petition from certain citizens of the Commonwealth praying that the Government make grants available to relieve the increased costs of educating children attending Catholic schools.

Petitions severally received.

- 3 MINISTERIAL ARRANGEMENTS: Mr Gorton (Prime Minister) informed the House that, during the absence abroad of Mr Freeth (Minister for External Affairs), Mr Fairhall (Minister for Defence) would act as Minister for External Affairs.
- 4 QUESTIONS: Questions without notice were asked.
- 5 MARGINAL DAIRY FARM RECONSTRUCTION—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER: Mr Anthony (Minister for Primary Industry), by leave, made a ministerial statement informing the House of the efforts that have been made to institute a scheme for the reconstruction of marginal or low-income dairy farms in Australia, and of the present state of negotiations between the Commonwealth Government and the State governments, and, by command of His Excellency the Governor-General, presented the following paper:

 - Mr Bowen, by leave, made a ministerial statement in connection with the subject of the report, and, by command of His Excellency the Governor-General, presented the following paper:

In accordance with the provisions of standing order 107, he had given priority to the matter proposed by Mr Webb, namely, "The urgent necessity to achieve justice and goodwill in industry by providing effective conciliation machinery for the prevention and settlement of industrial disputes and by repealing the labour injunction and related contempt provisions of the present Conciliation and Arbitration Act".

The proposed discussion received the necessary support.

- 8 POSTPONEMENT OF NOTICES—Ordered—That notices Nos. 1 and 2, government business, be postponed until a later hour this day.
- 9 JUDICIARY BILL 1969: Mr Bowen (Attorney-General), pursuant to notice, presented a Bill for an Act relating to the Remuneration of the Justices of the High Court. Bill read a first time.
 - Mr Bowen moved-That the Bill be now read a second time.
 - Debate adjourned (Mr Connor), and the resumption of the debate made an order of the day for the next sitting.
- 10 JUDGES' REMUNERATION BILL 1969: Mr Bowen (Attorney-General), pursuant to notice, presented a Bill for an Act relating to the Remuneration of the Judges of Courts created by the Parliament, of the Presidential Members of the Commonwealth Conciliation and Arbitration Commission and of the Members of the Trade Practices Tribunal.
 - Bill read a first time.

Mr Bowen moved—That the Bill be now read a second time.

- Debate adjourned (Mr Connor), and the resumption of the debate made an order of the day for the next sitting.
- 11 POSTPONEMENT OF ORDERS OF THE DAY—Ordered—That orders of the day Nos. 1 to 4, government business, be postponed until a later hour this day.
- 12 COMMONWEALTH AID ROADS BILL 1969: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—Debate resumed by Mr C. K. Jones who moved, as an amendment—That all words after "That" be omitted with a view to inserting the following words in place thereof: "this House, while not opposing the Bill, regrets the Government's continuing refusal to plan expenditure of an amount at least equivalent to the proceeds of all the automotive fuel taxes on roads and associated facilities". Debate continued.

Debate adjourned (Mr Lee), and the resumption of the debate made an order of the day for a later hour this day.

13 TRAMWAY AND MOTOR OMNIBUS EMPLOYEES' ASSOCIATION AND MR O'SHEA—PAYMENT OF FINES—MINISTERIAL STATEMENT: Mr Bowen (Attorney-General), by leave, made a ministerial statement informing the House that, following the payment of fines due by the Tramway and Motor Omnibus Employees' Association and Mr O'Shea, instructions had been given for an application to be made to the Commonwealth Industrial Court to discharge the order against Mr O'Shea for his examination and for production of books. The question of his release would then be a matter for the Court.

Mr Webb asked leave to make a statement in connection with the matter. Objection being raised, leave not granted.

14 COMMONWEALTH AID ROADS BILL 1969: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time— And on the amendment moved thereto by Mr C. K. Jones, viz.—That all words after "That" be omitted with a view to inserting the following words in place thereof: "this House, while not opposing the Bill, regrets the Government's continuing refusal to plan expenditure of an amount at least equivalent to the proceeds of all the automotive fuel taxes on roads and associated facilities"—

Debate resumed.

Mr Patterson moved—That the debate be now adjourned. Question—put.
